Clause 1 – Agreement to Sell and Purchase

Seller agrees to sell and Buyer agrees to purchase the motor vehicle described above ("Vehicle") on the terms and conditions set forth in this Agreement.

Clause 2 – AS IS Condition; No Warranties

Buyer acknowledges that the Vehicle is sold AS IS, WHERE IS, with all faults, defects, and without any express or implied warranties, including but not limited to warranties of merchantability or fitness for a particular purpose. Buyer has had the opportunity to inspect the Vehicle and accepts it in its current condition.

Clause 3 – Title and Ownership

Seller warrants that Seller is the lawful owner of the Vehicle and has the right to sell it. Seller will provide Buyer with a valid and transferable title free of liens and encumbrances at Closing.

Clause 4 – Vehicle Disclosure

Seller discloses that, to the best of Seller's knowledge, the odometer reading is accurate and the Vehicle has not been subject to any known major accidents, flood damage, or salvage titles unless otherwise stated herein.

Clause 5 – Risk of Loss

Risk of loss or damage to the Vehicle shall pass to Buyer upon delivery and transfer of possession of the Vehicle.

Clause 6 – Payment Terms

Buyer shall pay the Purchase Price in full by cash, certified check, or other immediately available funds at Closing, unless otherwise agreed in writing.

Clause 7 – No Refunds or Recourse

Buyer acknowledges that all sales are final. No refunds, returns, or exchanges will be accepted after Closing.

Clause 8 – Taxes and Fees

Buyer is responsible for all taxes, registration fees, title transfer fees, and any other governmental fees associated with the purchase and ownership of the Vehicle.

Clause 9 – Indemnification

Buyer agrees to indemnify and hold Seller harmless from any claims, liabilities, or damages arising after Closing related to the Vehicle.

Clause 10 – Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____ without regard to conflicts of law principles. Any disputes shall be resolved exclusively in the courts of _____ County, _____.

Clause 11 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, understandings, and agreements, whether written or oral.

Clause 12 – Amendments

No amendment or modification of this Agreement shall be valid unless made in writing and signed by both parties.

Clause 13 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Clause 14 – Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original, and together constitute one agreement.
