Customer is responsible for removal of personal items from the vehicle prior to service. Repair Shop is not liable for loss or damage to personal property left in the vehicle.

Clause 1 – Authorization

Customer hereby authorizes Repair Shop to perform the repairs and services described above and agrees to pay for all

labor, parts, and materials used.

Clause 2 – Estimate

The price estimate provided is an approximation. If the cost exceeds the estimate, Repair Shop will notify Customer prior to exceeding such estimate if possible.

Clause 3 – Parts and Materials

Repair Shop may use new, used, or rebuilt parts at its discretion unless Customer specifies otherwise in writing.

Clause 4 – Delivery and Delay

Repair Shop will use reasonable efforts to complete repairs promptly. Repair Shop is not liable for delays caused by parts availability, unforeseen complications, or Customer delay.

Clause 5 – Payment

Payment is due upon completion of services unless otherwise agreed in writing. Late payments may incur interest and/or storage fees.

Clause 6 – Lien

Repair Shop shall have a lien on the vehicle and parts for the amount due under this contract until full payment is made.

Clause 7 – Warranty Disclaimer

Repair Shop disclaims all warranties except those expressly stated herein. Any warranty provided does not cover consequential damage or incidental expenses.

Clause 8 – Customer Responsibilities

Customer shall maintain insurance on the vehicle during the repair period and shall be responsible for any damage not caused by Repair Shop.

Clause 9 – Limitation of Liability

Repair Shop's liability shall be limited to the amount paid for services and parts. Repair Shop is not liable for loss or damage arising from delays, loss of use, or consequential damages.

Clause 10 – Governing Law

This Agreement shall be governed by the laws of the State of _____ without regard to conflicts of law principles.

Clause 11 – Dispute Resolution

Any disputes arising out of or relating to this Agreement shall be resolved by mediation or arbitration in _____ County, _____, unless otherwise agreed.

Clause 12 – Entire Agreement

This Agreement contains the entire agreement between the parties and supersedes all prior understandings.

Clause 13 – Amendments

No amendment to this Agreement shall be effective unless in writing and signed by both parties.

Clause 14 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Clause 15 – Notices

All notices required or permitted shall be in writing and delivered personally, by certified mail, or by email with confirmation to the addresses provided herein.

Clause 16 – Vehicle Pickup

Customer agrees to pick up the vehicle within ____ days of notification of completion. Failure to do so may result in storage fees.

Clause 17 – Storage Fees

If the vehicle is not picked up timely, Repair Shop may charge reasonable storage fees until pickup.

Clause 18 – Risk of Loss

Risk of loss or damage to the vehicle passes to Customer upon delivery. Repair Shop maintains reasonable precautions but is not liable for theft or damage beyond its control.

Clause 19 – Customer Acknowledgments

Customer acknowledges having read and understood this Agreement and accepts all terms and conditions.

Clause 20 – Signatures

This Agreement may be executed in counterparts and is effective upon signature by both parties.
