## Section 4 – Award of Contract

The Buyer reserves the right to award the contract to the Bidder whose bid is determined to be the most advantageous, considering price, qualifications, and other factors.

## Section 5 – Governing Law

This Bid Contract shall be governed by and construed in accordance with the laws of the United States and the applicable State law, without regard to conflict-of-law principles.

## Section 6 – Confidentiality

Bidder agrees to maintain the confidentiality of proprietary or sensitive information disclosed in connection with this bid and contract.

## Section 7 – Representations and Warranties

Bidder represents and warrants that it has the legal authority to enter into this agreement and that no conflicts of interest

exist.

**Section 8 – No Collusion**

Bidder certifies that this bid is genuine and not made in the interest or on behalf of any undisclosed person, entity, or competitor.

**Section 9 – Taxes and Duties**

Bid prices are exclusive of applicable taxes, which shall be paid by the Buyer unless otherwise stated.

**Section 10 – Indemnification**

Bidder agrees to indemnify and hold Buyer harmless from any claims arising from Bidder's performance under any resulting contract.

**Section 11 – Insurance**

Bidder shall maintain appropriate insurance coverage as required for the project or services provided.

**Section 12 – Termination**

Buyer may terminate any resulting contract for convenience or cause under terms set forth in the solicitation and contract documents.

**Section 13 – Entire Agreement**

This Bid Contract, together with the solicitation documents and any attachments, constitutes the entire agreement between the parties.

**Section 14 – Amendments**

Any amendments or modifications to this Bid Contract must be in writing and signed by authorized representatives of both parties.

**Section 15 – Dispute Resolution**

Any disputes shall be resolved in accordance with the dispute resolution provisions specified in the solicitation documents.

**Section 16 – Assignment**

Bidder may not assign or subcontract performance without prior written consent of the Buyer.

**Section 17 – Acceptance**

Acceptance of this bid by the Buyer constitutes a binding contract subject to the terms herein and in the solicitation.

**Section 18 – Notices**

All notices under this Bid Contract shall be in writing and delivered to the addresses provided herein or as subsequently designated.

**Section 19 – Severability**

If any provision is deemed unenforceable, the remainder shall continue in full force and effect.

**Section 20 – Counterparts and Signatures**

This Bid Contract may be executed in counterparts, including by electronic means, each of which shall be deemed an original.
