1. Agreement to Provide Services

Photographer agrees to provide boudoir photography services as described above and Client agrees to pay for these services under the terms set forth in this Agreement.

2. Session Details and Preparation

Client agrees to attend the photography session on the scheduled date and time, prepared as advised by Photographer. Photographer will provide creative direction and guidance during the session to ensure quality results.

3. Ownership of Images; License to Client

All photographs created by Photographer are the exclusive property of Photographer. Photographer grants Client a limited, non-transferable license to use the delivered images for personal, non-commercial purposes only.

4. Model Release and Usage

Client grants Photographer the right to use photographs for portfolio, promotional, advertising, and marketing purposes unless Client specifically declines in writing prior to the session.

5. Payment and Deposits

A non-refundable deposit is required to secure the session date. The remaining balance is due before or at the time of the session. Photographer reserves the right to cancel or reschedule sessions if payment conditions are not met.

6. Cancellation and Rescheduling

Client may reschedule the session with at least 48 hours' notice without penalty. Cancellations with less than 48 hours' notice result in forfeiture of deposit. Unforeseen circumstances will be handled with reasonable accommodation by both parties.

7. Client Responsibilities

Client agrees to be punctual and communicate any specific requirements or concerns prior to the session. Client represents that all information provided is accurate and truthful.

8. Photographer Responsibilities

Photographer agrees to deliver the agreed-upon services in a professional manner and within the agreed timeframe for delivery of final images.

9. Liability and Indemnification

Photographer is not liable for any injuries, losses, or damages arising from the session or use of images. Client agrees to indemnify and hold Photographer harmless from any claims arising from Client's actions during the session.

10. Confidentiality and Privacy

Photographer respects Client's privacy and agrees not to disclose personal information except as required by law or as agreed upon in writing.

11. Governing Law and Dispute Resolution

This Agreement shall be governed by the laws of the State of _____. Any disputes arising under this Agreement shall be resolved through binding arbitration in _____ County, _____.

12. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, oral or written, related to the subject matter herein.

13. Amendments

Any modifications or amendments to this Agreement must be made in writing and signed by both parties to be effective.

14. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

15. Force Majeure

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including but not limited to acts of God, natural disasters, or governmental actions.

16. Waiver

Failure to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other provisions.

17. Headings

Section headings are for convenience only and shall not affect the interpretation of this Agreement.

18. Notices

All notices under this Agreement shall be in writing and delivered personally, by certified mail, or by electronic communication with confirmation.

19. Photography Style and Artistic Control

Photographer retains sole artistic control over the styling, composition, and editing of photographs and Client acknowledges this creative discretion.

20. Signatures and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together constitute one agreement.
