

BOXING PROFESSIONAL SERVICES AGREEMENT

RECITALS:

WHEREAS, Promoter seeks to engage Boxer to perform professional boxing services (the "Services") under the terms set forth herein; and WHEREAS, Boxer desires to provide such Services and enter into this Agreement on the terms and conditions contained herein.

1. TERM OF AGREEMENT

This Agreement shall commence on the Effective Date and continue until completion of the Services or termination pursuant to this Agreement.

2. SERVICES PROVIDED

Boxer agrees to participate in the boxing event(s) promoted by Promoter as scheduled, to perform to the best of Boxer's ability, and to comply with all applicable rules, regulations, and standards of the sport and governing athletic commissions.

3. COMPENSATION

Promoter agrees to pay Boxer the guaranteed purse amount of \$_____, payable as follows: (a) Deposit of \$_____ upon execution of this Agreement; (b) Balance upon completion of the event, subject to applicable deductions and withholdings.

Any additional compensation such as win bonuses, performance bonuses, or other remuneration shall be as set forth in writing and signed by both parties.

4. PROMOTER'S OBLIGATIONS

Promoter shall be responsible for arranging the venue, obtaining all necessary licenses and permits, ensuring compliance with all applicable laws and regulations, providing adequate security and medical personnel, and promoting the event in good faith.

5. BOXER'S REPRESENTATIONS AND WARRANTIES

Boxer represents that (a) Boxer is in excellent physical condition and fit to compete; (b) Boxer has no medical

conditions that would impair performance or pose undue risk; (c) Boxer holds all necessary licenses and is compliant with the applicable boxing commission(s); (d) Boxer will comply with all rules and regulations; (e) Boxer is not under contract with any other promoter or party that would conflict with this Agreement.

6. MEDICAL EXAMINATIONS AND TESTING

Boxer agrees to submit to all medical examinations, drug testing, and other health-related protocols required by the Promoter or governing athletic commission. Failure to comply may result in immediate termination of this Agreement.

7. INSURANCE

Promoter shall maintain appropriate insurance coverage for the event, including participant liability insurance. Boxer is encouraged to maintain personal health and accident insurance.

8. TERMINATION

Either party may terminate this Agreement for cause upon written notice if the other party materially breaches any term and fails to cure within fourteen (14) days of notice. Promoter may terminate immediately if Boxer fails to pass medical examinations or drug testing, or engages in conduct detrimental to the event.

9. INDEMNIFICATION

Each party shall indemnify and hold harmless the other party and its affiliates, officers, agents, and employees from and against any and all claims, damages, liabilities, and expenses arising out of or related to the breach of this Agreement or the negligence or willful misconduct of the indemnifying party.

10. CONFIDENTIALITY

The parties agree to keep the terms of this Agreement and any proprietary or confidential information learned during the term confidential, except as required by law or with prior written consent.

11. GOVERNING LAW AND VENUE

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflicts of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

12. WAIVER OF JURY TRIAL

TO THE MAXIMUM EXTENT PERMITTED BY LAW, EACH PARTY KNOWINGLY AND VOLUNTARILY WAIVES ANY RIGHT TO A TRIAL BY JURY IN ANY ACTION OR PROCEEDING ARISING OUT OF OR RELATING TO THIS AGREEMENT.

13. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof and supersedes all prior negotiations, agreements, or understandings, whether written or oral. Any amendments or modifications must be in writing and signed by both parties.

14. SEVERABILITY

If any provision of this Agreement is determined to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

15. NOTICES

All notices under this Agreement shall be in writing and delivered personally, by certified mail (return receipt requested), nationally recognized overnight courier, or email with confirmation of receipt, to the addresses set forth above or as otherwise designated in writing.
