Health and Warranty:

Breeder represents that the animal is in good health and free from communicable diseases at the time of breeding. Client acknowledges that breeding outcomes cannot be guaranteed and accepts all inherent risks. Breeder makes no warranties, express or implied, including but not limited to fertility, conception, or live birth.

Responsibilities and Care:

Client agrees to provide proper care and nutrition to the animal during the breeding period and to notify Breeder immediately of any health concerns. Breeder agrees to provide standard breeding management and to notify Client of any issues that may affect breeding success.

Liability and Indemnification:

Client assumes all risks associated with the breeding process, including but not limited to injury or death of the animal. Client agrees to indemnify and hold Breeder harmless from any claims, damages, or expenses arising out of or related to this Agreement, except to the extent caused by Breeder's gross negligence or willful misconduct.

Termination and Cancellation:

This Agreement may be terminated by either party upon written notice if the animal becomes unfit for breeding, dies, or if either party breaches any material term of this Agreement. No refunds will be issued for services already rendered. Any unused services or fees may be subject to terms outlined herein.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, USA, without regard to conflict-of-law principles. Any disputes arising out of or related to this Agreement shall be resolved through binding arbitration in _____ County, _____, in accordance with the rules of the American Arbitration Association. The parties knowingly and voluntarily waive their right to a trial by jury for any such dispute.

Entire Agreement and Amendments:

This Agreement, including any attached Addenda or Schedules, constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior negotiations and understandings. No amendment or modification shall be effective unless in writing and signed by both parties.

Notices:

All notices required or permitted under this Agreement shall be in writing and deemed given when delivered personally, sent by certified mail return receipt requested, nationally recognized overnight courier, or by electronic means with confirmation of receipt, to the parties at the addresses set forth above or to such other address as either party may designate by notice.

Severability:

If any provision of this Agreement is found to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect and shall be construed so as to best effectuate the original intent of the parties.
