Cancellations made between 15 and 30 days before the event forfeit 50% of the deposit amount. Cancellations made less than 15 days before the event forfeit the entire deposit and may incur additional fees. No refunds will be issued for payments made after the deposit.

Client Responsibilities:

Client is responsible for providing a suitable workspace with adequate lighting and access to electrical outlets. Client shall ensure attendees arrive on time and are ready for hair and makeup services as scheduled. Client agrees to disclose any allergies, skin sensitivities, or medical conditions that may affect services prior to the event date.

Service Provider Responsibilities:

Service Provider shall arrive on time and fully prepared with necessary equipment and products. Service Provider

agrees to perform services professionally and in accordance with industry standards. Service Provider reserves the right to refuse service if unsafe or unsanitary conditions are present.

Liability and Indemnification:

Client releases and holds harmless the Service Provider from any liability for injury, loss, or damage resulting from participation in the services provided. Client agrees to indemnify and defend the Service Provider against any claims arising from Client's negligence or failure to disclose pertinent information.

Force Majeure:

Neither party shall be held liable for failure to perform due to causes beyond their reasonable control, including but not limited to acts of God, natural disasters, government restrictions, pandemics, or other unforeseeable events.

Governing Law and Dispute Resolution:

This Contract shall be governed by and construed in accordance with the laws of the United States and the state where the services are provided, without regard to conflict of law principles. Any disputes arising shall be resolved through mediation, and if unsuccessful, through binding arbitration in accordance with the rules of the American Arbitration Association.

Entire Agreement:

This Contract constitutes the entire agreement between the parties and supersedes all prior agreements, understandings, or representations. Any modifications must be made in writing and signed by both parties.

Severability:

If any provision of this Contract is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.
