## Terms and Conditions:

### Clause 1 – Agreement to Perform Services

Provider agrees to deliver the cheer performance services as detailed in this Agreement, and Client agrees to pay for such services according to the terms herein.

### Clause 2 – Performance Standards and Conduct

Provider shall perform services professionally, abiding by all applicable laws, event rules, and safety regulations. Provider is responsible for the conduct of all personnel involved in services.

### Clause 3 – Cancellation and Rescheduling

Either party may cancel or reschedule the performance with at least 48 hours' written notice. Fees for cancellations made with less than 48 hours' notice may be forfeited as liquidated damages.

### Clause 4 – Payment and Refunds

Client shall pay the total fee in accordance with the agreed payment schedule. No refunds shall be issued for partial or full performance completed unless explicitly agreed in writing.

### Clause 5 – Liability and Indemnification

Provider is not liable for any indirect, incidental, or consequential damages. Client agrees to indemnify and hold

Provider harmless from any claims related to the performance except for gross negligence or willful misconduct by Provider.

**Clause 6 – Force Majeure**

Neither party shall be liable for delays or failure to perform due to causes beyond their reasonable control, including but not limited to natural disasters, acts of government, or other unforeseen events.

**Clause 7 – Confidentiality**

Both parties agree to keep the terms of this Agreement confidential and not disclose any non-public information without prior written consent unless required by law.

**Clause 8 – Intellectual Property**

All intellectual property rights related to the performance, including but not limited to choreography, music, and costumes, remain the property of the Provider unless otherwise agreed.

**Clause 9 – Governing Law and Jurisdiction**
