Clause 1 – Agreement to Enroll

The Student hereby enrolls in the Course identified above and agrees to abide by all rules, regulations, and policies of the Institution governing student conduct and course participation.

Clause 2 – Tuition and Fees

The Student agrees to pay the Tuition Fee as stipulated above. Payment shall be made according to the Payment Schedule using the selected Payment Method. Failure to pay tuition and fees on time may result in suspension or termination of enrollment.

Clause 3 – Attendance and Participation

The Student agrees to attend classes regularly, actively participate in course activities, and complete all assignments and examinations in a timely manner as required by the Instructor and the Institution.

Clause 4 – Code of Conduct

The Student agrees to conduct themselves in a professional and respectful manner at all times on Institution premises and during all related activities. The Institution reserves the right to discipline or dismiss any student who violates the code of conduct.

Clause 5 – Intellectual Property

All course materials provided by the Institution, including but not limited to lectures, handouts, and digital content, remain the sole property of the Institution. The Student agrees not to reproduce, distribute, or use these materials for any purpose other than personal study without prior written consent.

Clause 6 – Cancellation and Refund Policy

The Student may cancel enrollment by providing written notice to the Institution. Refunds, if any, shall be provided in accordance with the Institution's published refund policy, which is incorporated herein by reference.

Clause 7 – Liability and Indemnification

The Student assumes all risks related to participation in the Course and releases the Institution from any liability for injury, loss, or damage arising from enrollment or participation. The Student agrees to indemnify and hold harmless the Institution against any claims related to their participation.

Clause 8 – Privacy and Data Protection

The Institution will collect and use personal information of the Student solely for the purposes related to Course enrollment and administration, consistent with applicable privacy laws. The Student consents to such use and to receiving communications related to the Course.

Clause 9 – Dispute Resolution

Any disputes arising under or relating to this Agreement shall be resolved first through good faith negotiations between the parties. If unresolved, disputes shall be subject to mediation or binding arbitration as provided by applicable laws of the State of _____.

Clause 10 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles.

Clause 11 – Entire Agreement

This Agreement constitutes the entire agreement between the Student and the Institution with respect to the subject matter herein and supersedes all prior or contemporaneous agreements, representations, and understandings, whether oral or written.

Clause 12 – Amendments

No amendment or modification to this Agreement shall be effective unless in writing and signed by both parties.

Clause 13 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be severed and the remainder of the Agreement shall remain in full force and effect.

Clause 14 – Waiver

Failure by either party to enforce any provision of this Agreement shall not be deemed a waiver of future enforcement of that or any other provision.

Clause 15 – Binding Effect

This Agreement shall be binding upon and inure to the benefit of the parties and their respective heirs, successors, and permitted assigns.

Clause 16 – Notices

All notices required or permitted under this Agreement shall be in writing and shall be deemed delivered when personally delivered, sent by nationally recognized overnight courier, certified mail return receipt requested, or by electronic means with confirmation of receipt.

Clause 17 – Counterparts

This Agreement may be executed in one or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.

Clause 18 – No Third-Party Beneficiaries

Nothing in this Agreement shall be construed to confer any rights or remedies upon any person other than the Student and the Institution.

Clause 19 – Headings

Headings used in this Agreement are for convenience only and shall not affect the interpretation of any provisions.

Clause 20 – Signature and Execution

The Student and Institution representatives executing this Agreement represent that they have full authority to enter into this Agreement and that this Agreement is effective as of the date of last signature below.
