Coaching and Mentoring Services:

Coach agrees to provide coaching and mentoring services to Client as described in this Agreement, tailored to Client's personal and professional development goals. Services may include one-on-one coaching sessions, goal setting, progress review, and accountability support, conducted via in-person meetings, telephone, or electronic communication as mutually agreed.

Term and Termination:

This Agreement shall commence upon the Effective Date and continue until terminated by either party upon written notice. Either party may terminate this Agreement at any time for any reason by providing written notice to the other party. Termination shall not relieve Client of any payment obligations for services rendered prior to termination.

Fees and Payment:

Client agrees to pay Coach the agreed fees for coaching and mentoring services as outlined in a separate fee schedule or invoice. Confidentiality:

Client acknowledges that coaching is not therapy and that Coach is not providing medical or psychological treatment.

Responsibilities of Client:

Client agrees to be open and honest, commit to the coaching process, and take full responsibility for their actions and decisions. Client understands that results depend on their efforts and Coach makes no guarantees of specific outcomes.

Limitation of Liability:

Coach shall not be liable for any indirect, consequential, or incidental damages arising from coaching services. Client agrees that Coach's total liability under this Agreement shall not exceed the total fees paid by Client to Coach.

Dispute Resolution:

Any disputes arising under or in connection with this Agreement shall be resolved first through good faith negotiation between the parties. If unresolved, disputes shall be submitted to mediation before a mutually agreed mediator in the State of _____. If mediation fails, either party may pursue any legal remedy available under applicable law.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflicts of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Entire Agreement; Amendments:

This Agreement constitutes the entire understanding between the parties related to its subject matter and supersedes all prior agreements or understandings, whether written or oral. Any amendments or modifications must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is found to be invalid, illegal, or unenforceable, the remaining provisions shall continue in full force and effect, and the invalid provision shall be replaced with a valid provision that most closely matches the parties' original intent.
