Service Provider warrants that services will be performed in a competent and professional manner. Service Provider shall maintain appropriate insurance coverage during the term of this Agreement. Service Provider shall not be liable

for any damage caused by pre-existing conditions or Client's failure to provide accurate information.

Indemnification:

Each party agrees to indemnify, defend, and hold harmless the other party from any claims, damages, losses, and expenses, including attorney fees, arising out of or resulting from the performance of this Agreement, except to the extent caused by the other party's negligence or willful misconduct.

Termination:

Either party may terminate this Agreement upon written notice if the other party breaches any material term and fails to cure such breach within a reasonable period. Termination shall not relieve Client of the obligation to pay for services performed prior to termination.

Force Majeure:

Neither party shall be liable for any failure or delay in performance due to causes beyond its reasonable control, including acts of God, natural disasters, governmental actions, or other unforeseeable events.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Dispute Resolution:

Any disputes arising under this Agreement shall first be attempted to be resolved through mediation, before pursuing any other legal remedies.

Severability:

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Waiver:

Failure or delay of either party to enforce any provision of this Agreement shall not be deemed a waiver of such provision or any other rights.
