Clause 1 – Agreement Purpose

Provider agrees to provide child care services for the Child named above, and Parent/Guardian agrees to pay for such services under the terms stated herein. This Agreement outlines the rights and responsibilities of both parties.

Clause 2 – Term and Termination

This Agreement shall commence on the date agreed by the parties and continue until terminated by either party with reasonable written notice. Provider may terminate immediately for cause, including child abuse, neglect, or violation of the Agreement.

Clause 3 – Health and Safety

Parent/Guardian certifies that the Child is in good health and agrees to notify Provider promptly of any health or behavioral conditions. Provider will take reasonable measures to ensure the Child's safety during care, but Parent/Guardian acknowledges inherent risks.

Clause 4 – Medication Authorization

Provider shall only administer medication to the Child if authorized in writing by Parent/Guardian, including dosage, timing, and instructions. Parent/Guardian agrees to provide all medications in original labeled containers.

Clause 5 – Emergency Procedures

In case of emergency, Provider is authorized to seek medical treatment for the Child if Parent/Guardian cannot be reached immediately. Parent/Guardian shall provide emergency contact information and medical authorization.

Clause 6 – Discipline Policy

Provider agrees to use positive discipline techniques and will not use corporal punishment. Parent/Guardian acknowledges that appropriate discipline methods may be used as described and agrees to communicate any concerns.

Clause 7 – Confidentiality

Both parties agree to keep confidential any personal information learned during the course of this Agreement except as required by law or to protect the Child's welfare.

Clause 8 – Liability

Provider shall maintain liability insurance for child care activities. Parent/Guardian agrees to hold Provider harmless from any claims arising from ordinary negligence but not from gross negligence or willful misconduct.

Clause 9 – Attendance and Absences

Parent/Guardian agrees to notify Provider of any planned absences. Payment obligations for absences shall be as specified in this Agreement.

Clause 10 – Meals and Nutrition

Provider will provide meals and snacks as agreed, accommodating any dietary restrictions provided in writing by Parent/Guardian.

Clause 11 – Personal Belongings

Parent/Guardian is responsible for providing necessary personal items. Provider is not liable for lost or damaged items.

Clause 12 – Changes to Agreement

Any amendments to this Agreement must be in writing and signed by both parties.

Clause 13 – Governing Law

This Agreement shall be governed by and construed under the laws of the State of _____, without regard to conflict of laws principles.

Clause 14 – Dispute Resolution

Any disputes arising under this Agreement shall first be addressed through good faith negotiation, followed by mediation if necessary. Legal action may only be pursued if alternative dispute resolution fails.

Clause 15 – Entire Agreement

This document contains the entire agreement between the parties relating to child care services and supersedes all prior agreements and understandings.

Clause 16 – Signatures
