RECITALS:

WHEREAS, Party A and Party B (collectively, the “Parties”) intend to enter into a legally binding marriage contract under the laws of the United States; and WHEREAS, the Parties desire to establish their respective rights and responsibilities regarding each other’s income and property and the ownership and disposition of property, as well as other terms and conditions of their relationship;

Section 1 – Marriage

The Parties agree to enter into marriage and commit to a mutual partnership based upon love, fidelity, respect, and support.

Section 2 – Property Ownership

All assets and property acquired by either Party before the marriage shall remain the separate property of that Party. Property acquired jointly during the marriage shall be considered marital property unless otherwise specified in this Agreement.

Section 3 – Financial Responsibilities

The Parties agree to share financial responsibilities equitably and to disclose all significant financial matters promptly and honestly to each other.

Section 4 – Debts

Each Party shall be responsible for debts individually incurred before the marriage. Debts incurred jointly or during the course of the marriage shall be the joint responsibility of both Parties.

Section 5 – Income and Support

The Parties agree to contribute to the household according to their abilities and to support each other financially and emotionally.

Section 6 – Decision Making

Decisions regarding significant family matters, including but not limited to residence, children, and major expenditures,

shall be made jointly by the Parties.

Section 7 – Dispute Resolution

Any disputes arising under this Agreement shall be resolved first through mediation. If mediation fails, disputes shall be resolved through binding arbitration in accordance with the laws of the applicable state.

Section 8 – Termination of Marriage

In the event of a dissolution of marriage, the Parties agree to equitable distribution of all marital property and to abide by applicable laws governing such dissolution.

Section 9 – Confidentiality

The Parties agree to keep the terms of this Agreement and all personal and financial information confidential except as required by law or as necessary to enforce the terms herein.

Section 10 – Amendments

Any amendments or modifications to this Agreement must be made in writing and signed by both Parties to be enforceable.

Section 11 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the state in which the Parties reside at the time of execution.

Section 12 – Entire Agreement

This Agreement contains the entire understanding of the Parties and supersedes all prior negotiations and agreements, whether oral or written.

Section 13 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Section 14 – Waiver

The failure to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other provision herein.

Section 15 – Execution

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.

Section 16 – Representations and Warranties

Each Party represents and warrants that they enter into this Agreement voluntarily, have had the opportunity to seek independent legal counsel, and fully understand the terms and consequences herein.

Section 17 – No Duress

The Parties affirm that they have entered into this Agreement free from any duress, coercion, or undue influence.

Section 18 – Independent Legal Advice

The Parties acknowledge that they have been advised to seek independent legal advice regarding this Agreement and that they fully understand their rights and obligations.

Section 19 – Execution in Electronic Form

The Parties agree that this Agreement may be executed by electronic signatures, which shall have the same force and effect as original signatures.

Section 20 – Notices

All notices under this Agreement shall be in writing and deemed given when delivered personally, sent by nationally recognized overnight courier, or sent by certified mail return receipt requested to the Parties at the addresses listed above or to such other address as either Party shall designate in writing.
