Clause 1 – Engagement and Services

The Instructor agrees to provide professional dance instruction services to the Client as described in this Agreement. Services shall be performed at the agreed location(s) and times. The Instructor shall use reasonable skill, care, and diligence in providing the services.

Clause 2 – Term of Agreement

This Agreement shall commence upon execution by both parties and shall continue until terminated as provided herein.

Clause 3 – Fees and Payment

The Client agrees to pay the Instructor the fees set forth above for each session. Payments shall be made according to the agreed payment schedule and method. Late payments may incur interest or penalties as permitted by law.

Clause 4 – Cancellation and Rescheduling

Either party may cancel or reschedule sessions with at least 24 hours' prior notice. Failure to provide timely notice may result in forfeiture of the fee for that session.

Clause 5 – Instructor's Obligations

The Instructor shall maintain all necessary qualifications, licenses, and insurance to perform the services. The Instructor shall comply with all applicable laws and regulations.

Clause 6 – Client’s Obligations

The Client shall provide a safe environment and necessary equipment for instruction. The Client shall comply with all applicable laws and cooperate reasonably with the Instructor.

Clause 7 – Liability and Indemnification

The Instructor shall not be liable for any injury, loss, or damage sustained by the Client during instruction except to the extent caused by gross negligence or willful misconduct. The Client agrees to indemnify and hold harmless the Instructor from any claims arising from Client’s negligence.

Clause 8 – Termination

Either party may terminate this Agreement upon written notice. Upon termination, the Client shall pay for all services rendered up to the termination date.

Clause 9 – Confidentiality

Both parties agree to keep confidential any proprietary or sensitive information disclosed during the term of this Agreement.

Clause 10 – Intellectual Property

Any choreography, teaching materials, or content created by the Instructor remain the sole property of the Instructor. The Client may not reproduce or distribute such materials without written consent.

Clause 11 – Non-Discrimination

The Instructor agrees to provide services without discrimination based on race, color, religion, sex, national origin, age, disability, or any other protected status.

Clause 12 – Force Majeure

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including natural disasters, pandemics, or other emergencies.

Clause 13 – Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____, without regard to conflict of laws principles. The parties consent to the exclusive jurisdiction and venue of state or federal courts located in _____ County, _____.

Clause 14 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, understandings, or agreements, whether written or oral.

Clause 15 – Amendments

Any amendment or modification of this Agreement shall be in writing and signed by both parties.

Clause 16 – Severability

If any provision is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Clause 17 – Waiver

Failure by either party to enforce any provision shall not be deemed a waiver of that provision or any other rights.

Clause 18 – Notices

All notices shall be in writing and delivered by hand, certified mail, recognized courier, or electronic means that allow confirmation of delivery.

Clause 19 – Independent Contractor

The Instructor is an independent contractor and not an employee, partner, or agent of the Client.

Clause 20 – Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together constitute one instrument.
