### Clause 1 – Agreement to Deliver

Sender agrees to deliver the described goods to the Receiver at the delivery location specified above, subject to the terms and conditions herein.

### Clause 2 – Risk of Loss

Risk of loss or damage to the goods passes from Sender to Receiver upon physical delivery at the designated delivery location.

### Clause 3 – Carrier Responsibilities

The Carrier shall transport the goods in a timely, safe, and lawful manner, complying with all applicable laws and regulations.

### Clause 4 – Payment Terms

Payment for delivery services shall be due in full upon receipt of invoice unless otherwise agreed in writing.

### Clause 5 – Liability and Insurance

Carrier is responsible for loss or damage to the goods occurring during transportation unless caused by an act of God, inherent nature of the goods, or Receiver's fault. Carrier shall maintain adequate insurance coverage.

### Clause 6 – Delays and Force Majeure

Neither party shall be liable for delays caused by circumstances beyond their reasonable control, including but not limited to natural disasters, strikes, or government actions.

**Clause 7 – Inspection and Acceptance**

Receiver shall inspect the delivered goods promptly and notify Sender and Carrier in writing of any damage, shortage, or discrepancies within 48 hours.

**Clause 8 – Indemnification**

Each party agrees to indemnify and hold harmless the other from any claims, damages, or expenses arising out of their negligence or willful misconduct.

**Clause 9 – Confidentiality**

All information exchanged between parties under this Contract shall be treated as confidential and shall not be disclosed to third parties except as required by law.

**Clause 10 – Governing Law and Jurisdiction**

Failure to enforce any provision of this Contract shall not constitute a waiver of that provision or any other rights.

This Contract may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one agreement.
