Photographer reserves the right to cancel with full refund of any fees paid, with no further liability.

Intellectual Property and Usage Rights:

Photographer retains all copyrights to the images produced. Client is granted a limited, non-exclusive license to use the images for personal, non-commercial purposes unless otherwise agreed in writing. Any commercial use, reproduction, or distribution requires Photographer's prior written consent.

Model Release and Privacy:

Client grants Photographer the right to use images for promotional and marketing purposes, including but not limited to website, social media, portfolio, and advertising, unless Client expressly opts out in writing. Photographer agrees to respect Client's privacy and not disclose sensitive information.

Liability and Indemnification:

Photographer shall perform services with reasonable care and skill but is not liable for any indirect, incidental, or consequential damages. Client agrees to indemnify and hold Photographer harmless from any claims arising from Client's breach of this Agreement or use of images.

Force Majeure:

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including acts of God, natural disasters, government restrictions, or other unforeseen events.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles. Any disputes arising hereunder shall be resolved by binding arbitration in _____ County, _____, in accordance with the rules of the American Arbitration Association.

Entire Agreement and Amendments:

This Agreement, together with any attached exhibits or addenda, constitutes the entire agreement between the parties and supersedes all prior agreements or understandings, whether written or oral. Amendments must be in writing and signed by both parties.

If any provision of this Agreement is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.
