Clause 1 – Purpose

This Agreement sets forth the terms and conditions under which the Family Technology Devices (hereafter “Devices”) shall be used by the Family Member named herein. The Family Member acknowledges understanding and acceptance of these terms.

Clause 2 – Authorized Use

The Devices shall be used solely for personal, educational, or family-approved activities. Unauthorized commercial use, installation of unapproved software, or access to restricted content is strictly prohibited.

Clause 3 – User Obligations

The Family Member agrees to use the Devices responsibly, avoid damage, maintain security measures (including passwords and software updates), and report any loss, theft, or malfunction immediately to the responsible adult.

Clause 4 – Privacy and Data Security

Family Members shall respect privacy rights of other family members and third parties. The Family Member shall not access, share, or disclose personal or confidential information without explicit permission.

Clause 5 – Maintenance

Routine maintenance, software updates, and necessary repairs shall be conducted by authorized parties only. The Family Member shall cooperate in providing access for such maintenance.

Clause 6 – Liability

The Family Member is responsible for reasonable care of the Devices. The family as a whole disclaims liability for damages arising from unauthorized use, negligence, or failure to comply with this Agreement.

Clause 7 – Indemnification

The Family Member agrees to indemnify and hold harmless other family members and guardians from claims or damages arising out of misuse or unauthorized actions involving the Devices.

Clause 8 – Term

This Agreement remains in effect until modified or terminated by mutual consent of responsible adults and the Family Member, or upon return of the Devices.

Clause 9 – Termination

This Agreement may be terminated for cause, including but not limited to misuse, intentional damage, or violation of terms. Upon termination, Devices must be returned immediately.

Clause 10 – Dispute Resolution

Any disputes arising under this Agreement shall be resolved through family discussion or mediation. Legal remedies may be pursued only as a last resort.

Clause 11 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United States of America and the applicable state laws.

Clause 12 – Confidentiality

All information relating to this Agreement and use of Devices shall be treated confidentially within the family and not disclosed to outside parties except as required by law.

Clause 13 – Amendments

Any amendment to this Agreement must be in writing and signed by all parties involved.

Clause 14 – Entire Agreement

This document represents the entire agreement between the parties concerning the use of the Devices and supersedes any prior agreements or understandings.

Clause 15 – Severability

If any provision of this Agreement is deemed invalid or unenforceable, the remainder of the Agreement shall remain in full force and effect.

Clause 16 – Waiver

No waiver of any breach or default shall be deemed a waiver of any subsequent breach or default.

Clause 17 – Responsibilities of Guardians

Guardians shall provide guidance, enforce this Agreement, and ensure the safety and appropriate use of the Devices.

Clause 18 – Educational Use Encouragement

Family Members are encouraged to utilize the Devices primarily for educational and productive purposes.

Clause 19 – Backup and Data Loss

Family Members acknowledge the risk of data loss and are encouraged to regularly backup important data. The family is not liable for any data loss.

Clause 20 – Signatures

This Agreement is executed by the parties below, signifying acceptance and agreement to the terms herein.
