The Designer shall deliver final designs and any agreed materials in accordance with the agreed timeline.

Intellectual Property Rights:

All designs, sketches, and related materials created by the Designer under this Agreement are the exclusive property of the Client upon full payment. The Designer retains the right to use the designs for portfolio and promotional purposes unless otherwise agreed in writing.

Confidentiality:

Both parties agree to maintain the confidentiality of proprietary information disclosed in connection with this Agreement and not to disclose such information to any third party without prior written consent except as required by law.

Term and Termination:

This Agreement commences upon execution by both parties and continues until completion of services or termination by either party upon written notice. Upon termination, Client shall pay Designer for all work performed through the termination date.

Warranties and Representations:

Designer represents that all services will be performed in a professional and workmanlike manner and that the Designer has full right to enter into this Agreement. Client represents that it has authority to engage Designer for the services described herein.

Indemnification:

Each party agrees to indemnify and hold harmless the other party from any claims, liabilities, damages, or expenses arising out of breach of this Agreement or negligence in performance of obligations hereunder.

Limitation of Liability:

Neither party shall be liable for any indirect, incidental, consequential, or punitive damages arising out of or related to this Agreement, even if advised of the possibility of such damages.

Independent Contractor:

Designer is an independent contractor and not an employee or agent of Client. Designer shall control the means and methods of performing the services and shall be responsible for all taxes and benefits related to compensation.

Governing Law and Dispute Resolution:

This Agreement shall be governed by the laws of the State of _____ without regard to conflict of law principles. Any disputes shall be resolved by binding arbitration in _____ County, _____, in accordance with the rules of the American Arbitration Association.

Entire Agreement and Amendments:

This Agreement, along with any attachments or schedules, constitutes the entire understanding between the parties and supersedes all prior agreements. Amendments must be in writing and signed by both parties.

Notices:

All notices required or permitted under this Agreement shall be in writing and delivered personally, by certified mail, or by nationally recognized overnight courier to the addresses provided above.

Severability:

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
