Clause 1 – Agreement to Participate

Participant agrees to enter the Golf Tournament organized by the Organizer under the terms and conditions set forth herein and abide by all rules and regulations established by the Organizer and the golf course.

Clause 2 – Eligibility and Conduct

Participant represents that they meet all eligibility requirements to compete in the Tournament. Participant agrees to conduct themselves in a sportsmanlike manner and comply with the Rules of Golf as published by the United States Golf Association (USGA) and local rules of the venue.

Clause 3 – Entry Fees and Refunds

Participant agrees to pay the required entry fee in full prior to the Tournament start. Entry fees are non-refundable except in the case of Tournament cancellation or as otherwise determined by the Organizer at their sole discretion.

Clause 4 – Schedule and Format

The Tournament format and schedule shall be as specified by the Organizer. The Organizer reserves the right to modify the format, schedule, or rules as necessary for the smooth conduct of the Tournament.

Clause 5 – Prizes and Awards

Prizes will be awarded as specified by the Organizer. All decisions regarding prizes and awards are final. Participants

are responsible for any taxes or fees associated with prizes.

Clause 6 – Liability and Assumption of Risk

Participant assumes all risks related to participation in the Tournament, including but not limited to personal injury or property damage. Participant releases and holds harmless the Organizer, golf course, sponsors, and their respective agents and employees from any liability arising out of participation.

Clause 7 – Weather and Cancellation

The Organizer may postpone, reschedule, or cancel the Tournament in case of inclement weather or other unforeseen circumstances. Entry fees will be refunded only if the Tournament is canceled and not rescheduled.

Clause 8 – Use of Likeness

Participant grants the Organizer the right to use their name, image, and likeness in any promotional materials or media related to the Tournament without compensation.

Clause 9 – Governing Law and Jurisdiction

This Agreement shall be governed by the laws of the State of _____. Any disputes arising out of this Agreement or the Tournament shall be resolved exclusively in the state or federal courts located within _____ County, _____.

Clause 10 – Entire Agreement

This Agreement constitutes the entire agreement between the parties with respect to the Tournament and supersedes all prior understandings. No modification shall be effective unless in writing signed by both parties.

Clause 11 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Clause 12 – Participant Information

Participant consents to the collection and use of personal information for the purpose of Tournament administration and communication in compliance with applicable law.

Clause 13 – Equipment and Safety

Participant is responsible for ensuring that their equipment complies with Tournament rules and safety standards. The Organizer is not responsible for any equipment damage or loss.

Clause 14 – Amendments

The Organizer reserves the right to amend these terms and conditions at any time with notice to participants.

Clause 15 – Acceptance

By signing below, Participant acknowledges that they have read, understand, and agree to the terms and conditions set forth in this Agreement.
