Terms and Conditions:

1. Membership Eligibility

Member represents that they are at least 18 years old or have obtained the necessary parental or guardian consent to participate in gym activities and use the facilities. Member agrees to provide accurate and complete information as requested by the Gym.

2. Use of Facilities

Member shall use the facilities and equipment in a safe and responsible manner, abiding by all posted rules and instructions from Gym staff. The Gym reserves the right to suspend or terminate membership for violation of rules or unsafe conduct.

3. Health and Safety

Member acknowledges that the use of gym facilities and equipment involves inherent risks, including risk of injury. Member agrees to consult a physician prior to beginning any exercise program. Member assumes all risks associated with their use of the facilities and releases the Gym from liability.

4. Payment and Fees

Member agrees to pay all fees as outlined in the membership details. Monthly fees are due in advance and non-refundable. The Gym reserves the right to modify fees with 30 days' prior notice to the Member.

5. Term and Termination

Membership commences on the Start Date and continues for the Duration indicated, unless terminated earlier according to this agreement. Member may cancel the membership with written notice in accordance with Gym's cancellation policy. The Gym may terminate membership for cause or unpaid fees.

6. Access and Security

Member shall not share membership credentials or access cards with others. Unauthorized use of membership privileges may result in suspension or termination.

7. Personal Property

Member is solely responsible for personal belongings brought into the Gym. The Gym is not liable for loss, theft, or

damage to personal property.

8. Liability and Indemnification

Member hereby releases and holds harmless the Gym, its owners, employees, and agents from any claims, liabilities, damages, or expenses arising from Member's use of the facilities, except for gross negligence or willful misconduct by the Gym.

9. Photography and Media

Member consents to the Gym's use of photographs or video taken on premises for promotional purposes unless otherwise notified in writing.

10. Governing Law and Dispute Resolution

This Agreement shall be governed by the laws of the United States and the State where the Gym is located, without regard to conflict-of-law principles. Any disputes shall be resolved in the state or federal courts located in the Gym's jurisdiction. The parties waive the right to trial by jury to the maximum extent permitted by law.

11. Entire Agreement

This document constitutes the entire agreement between the Gym and the Member regarding membership and supersedes all prior agreements or understandings.

12. Amendments

Any amendments to this Agreement must be in writing and signed by both parties.

13. Waiver

Failure by either party to enforce any provision shall not be deemed a waiver of future enforcement of that or any other provision.

14. Severability

If any provision of this Agreement is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.

15. Emergency Contact

Member agrees to provide emergency contact information and authorize the Gym to contact this person in case of emergency.

16. Code of Conduct

Member agrees to behave respectfully toward staff and other members and to comply with all Gym policies.

17. Use of Personal Trainers and Services

Services provided by personal trainers or third parties are separate from this Agreement. The Gym is not responsible for actions or advice provided by third parties.

18. COVID-19 and Other Health Policies

Member agrees to comply with all health and safety guidelines implemented by the Gym, including those related to communicable diseases.

19. Membership Freeze and Suspension

Member may request to freeze or suspend membership subject to Gym's policies and fees.

20. Signatures and Acknowledgment

Member acknowledges having read, understood, and agreed to all terms and conditions stated herein.
