Clause 1 – Agreement Purpose

This Agreement establishes the terms and conditions under which the Service Provider will supply hair extension products and/or perform hair extension installation services for the Client, as outlined herein.

Clause 2 – Hair Extension Products

The Service Provider agrees to supply hair extension products that are of professional quality, authentic, and suitable for the services described. The Client acknowledges that hair extension colors and textures may vary slightly due to natural characteristics.

Clause 3 – Services Provided

The Service Provider shall perform the hair extension installation and associated services in a professional, skillful manner consistent with industry standards. Services will be performed at the agreed location and within the estimated timeframe.

Clause 4 – Client Responsibilities

The Client agrees to provide accurate information regarding allergies, scalp conditions, and hair history. The Client acknowledges that proper aftercare is essential to maintaining the integrity and appearance of the hair extensions.

Clause 5 – Payment

The Client shall pay the agreed total price as specified above. Deposit amounts, if any, are non-refundable except where otherwise stated. Final payment is due according to the schedule established in this Agreement.

Clause 6 – Cancellation and Rescheduling

The Client must provide at least 48 hours advance notice for cancellation or rescheduling of appointments. Failure to do so may result in forfeiture of deposit or additional fees as determined by the Service Provider.

Clause 7 – Hair Extension Care and Maintenance

The Client agrees to follow all care instructions provided by the Service Provider. The Service Provider is not responsible for damage resulting from improper care or use of products not recommended herein.

Clause 8 – Warranty and Liability

The Service Provider warrants that services will be rendered with reasonable care and skill. However, no guarantees are made regarding the longevity or performance of hair extensions, as these depend on multiple factors including Client care.

Clause 9 – Health and Safety

Both parties agree to adhere to all applicable health and safety regulations. The Client confirms that no contagious scalp or skin conditions exist at the time of service.

Clause 10 – Privacy and Confidentiality

Personal information collected in connection with this Agreement will be handled in compliance with applicable privacy laws and used solely for the purposes of providing services and complying with legal obligations.

Clause 11 – Governing Law and Dispute Resolution

This Agreement shall be governed by the laws of the United States and, where applicable, the specific state governing the Service Provider's business location. Any disputes arising shall be resolved through negotiation or mediation prior to pursuing legal action.

Clause 12 – Entire Agreement and Amendments

This document constitutes the entire Agreement between the parties. Any modifications or amendments must be made in writing and signed by both parties.

Clause 13 – Severability

If any provision of this Agreement is found to be unenforceable or invalid, the remaining provisions shall continue in

full force and effect.

Clause 14 – Force Majeure

Neither party shall be liable for failure to perform due to events beyond reasonable control, including but not limited to natural disasters, acts of government, or other force majeure events.

Clause 15 – Signatures and Execution

This Agreement may be executed in counterparts and by electronic signature, each of which shall be deemed an original. By signing, both parties agree to be bound by the terms herein.
