## Boarding Terms and Conditions:

### 1. Services Provided

Owner agrees to provide boarding services for Boarder's horse as described herein. Services include stall or pasture boarding, feeding, watering, and basic care unless otherwise agreed.

### 2. Boarding Fees and Payment

Boarder agrees to pay boarding fees as set forth by Owner. Fees are due in advance and payable monthly. Late payments may incur additional charges or termination of boarding privileges.

### 3. Care and Feeding

Owner will provide feed and water for the horse in accordance with Boarder's instructions. Boarder shall supply feed unless otherwise agreed. Owner is not responsible for changes in feeding or supplements not provided by Boarder.

### 4. Health and Veterinary Care

Boarder shall be responsible for all veterinary care, including vaccinations, deworming, and emergency treatment. Owner shall notify Boarder promptly of any health concerns. Owner may arrange emergency veterinary care at Boarder's expense if Boarder is unavailable.

### 5. Liability and Indemnification

Boarder assumes all risk of injury or loss to the horse while on Owner's premises. Owner is not liable for injury, death, theft, or disease unless due to Owner's gross negligence or willful misconduct. Boarder agrees to indemnify and hold Owner harmless from any claims arising from Boarder's horse.

## **6. Emergencies and Notifications**

Owner shall make reasonable efforts to contact Boarder or designated emergency contacts in case of emergency. If unable to reach Boarder, Owner may authorize veterinary or other emergency care at Boarder's expense.

## **7. Term and Termination**

This Agreement shall continue until terminated by either party with written notice. Owner may terminate immediately for non-payment or violation of rules. Boarder shall remove horse promptly upon termination.

## **8. Rules and Regulations**

Boarder agrees to abide by all posted rules and reasonable regulations established by Owner for safety and welfare of horses and persons on premises.

## **9. Personal Property**

Boarder's tack and personal property are stored at Boarder's risk. Owner is not responsible for loss or damage of personal property.

## **10. Emergencies Beyond Control**

Owner shall not be liable for loss or damage resulting from fire, theft, disease, acts of God, or other events beyond Owner's control.

## **11. Insurance**

Boarder is encouraged to maintain appropriate insurance for the horse and liability. Owner's insurance does not cover Boarder's horse or personal property.

## **12. Governing Law and Venue**
