Service Provider's total liability, if any, shall not exceed the total amount paid by Client under this Agreement.

CONFIDENTIALITY:

Each party agrees to keep confidential and not disclose to any third party any proprietary or confidential information obtained during the course of this Agreement, except as required by law or with the other party's prior written consent.

INDEPENDENT CONTRACTOR STATUS:

Service Provider is an independent contractor and nothing in this Agreement shall be construed to create a partnership, joint venture, or employer-employee relationship between the parties.

DISPUTE RESOLUTION:

Any dispute arising out of or relating to this Agreement shall be resolved first by informal negotiation between the parties. If unresolved, the dispute shall be governed by the laws of the State of _____ without regard to conflicts of law principles, and the parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

ENTIRE AGREEMENT:

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, representations, or understandings, oral or written. No amendment or modification shall be effective unless in writing and signed by both parties.

SEVERABILITY:

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.
