1. Internship Position and Duties

The Company hereby agrees to engage the Intern as an intern in the position agreed upon by both parties. The Intern agrees to perform duties and responsibilities as assigned by the Company, consistent with the internship role. The Intern shall report to the supervisor designated by the Company.

2. Term and Schedule

The internship shall commence on the agreed start date and continue until the agreed end date or until terminated by either party in accordance with this Agreement. The Intern shall work the schedule mutually agreed upon, which may be adjusted by the Company with reasonable notice.

3. Compensation

This internship is unpaid and does not constitute employment. The Intern understands and agrees that he/she is not entitled to wages, salary, or other compensation from the Company except as may be expressly stated in writing. Any stipend, if applicable, will be specified separately.

4. Confidentiality

The Intern agrees to maintain the confidentiality of any proprietary or confidential information received during the internship. This obligation shall survive the termination of this Agreement.

5. Intellectual Property

Any work product, inventions, or other materials developed by the Intern during the course of the internship related to the Company's business shall be the sole property of the Company. Intern agrees to assign all rights to such work product to the Company.

6. Termination

Either party may terminate this Agreement at any time upon written notice to the other party. Upon termination, the Intern shall promptly return all Company property and materials.

7. No Employment Relationship

This Agreement does not create an employment relationship between the Company and the Intern. The Intern understands that he/she is not eligible for any benefits provided to employees of the Company.

8. Compliance with Laws and Policies

The Intern agrees to comply with all applicable laws, regulations, and Company policies during the internship.

9. Liability and Indemnification

The Intern acknowledges that he/she participates in the internship at his/her own risk. The Intern releases and agrees to indemnify and hold harmless the Company from any claims, damages, or liabilities arising from the internship, except to the extent caused by the Company's gross negligence or willful misconduct.

10. Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising under this Agreement shall be subject to the exclusive jurisdiction of the state or federal courts located in _____ County, _____.
