Limitation of Liability:

Neither party shall be liable to the other for any indirect, incidental, special, consequential, or punitive damages arising from or related to this Agreement, regardless of the form of action, even if advised of the possibility of such damages.

Termination:

Either party may terminate this Agreement upon written notice if the other party materially breaches any provision herein and fails to cure within thirty (30) days after receipt of such notice. Upon termination, Client shall pay Lance for all services performed through the termination date.

Independent Contractor:

Lance is engaged as an independent contractor. Nothing in this Agreement shall be construed to create an employer-employee, agency, joint venture, or partnership relationship between the parties.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law provisions. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____. The parties waive any right to a trial by jury.

Entire Agreement:

This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior or contemporaneous communications, representations, or agreements, whether oral or written. Any amendments must be in writing and signed by both parties.

Notices:

All notices under this Agreement shall be in writing and shall be deemed given upon personal delivery, overnight courier, certified mail return receipt requested, or email with confirmed receipt, to the parties at their addresses set forth herein or at such other address as either party may designate in writing.

Force Majeure:

Neither party shall be liable for any failure or delay in performance due to causes beyond its reasonable control, including but not limited to acts of God, natural disasters, governmental actions, war, terrorism, or labor disputes.

Severability:

If any provision of this Agreement is determined to be invalid or unenforceable, the remaining provisions shall remain in full force and effect, and the invalid provision shall be replaced by a valid provision that most closely matches the original intent.

Counterparts and Electronic Signatures:

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument. Signatures transmitted by electronic means shall be deemed to have the same legal effect as originals.
