Clause 1 – Scope of Services

The Makeup Artist agrees to provide professional makeup services as described herein to the Client on the agreed date and at the specified location. Services include application, consultation, and any agreed-upon makeup enhancements.

Clause 2 – Appointment and Scheduling

The appointment date and time are as specified above. The Makeup Artist agrees to be punctual and prepared. The Client agrees to be available at the scheduled time and location. Any changes must be communicated at least 48 hours prior to the appointment.

Clause 3 – Payment and Deposits

The Client shall pay the total price as stated. A non-refundable deposit may be required to secure the appointment. The remaining balance is due on or before the appointment date. Payment methods accepted include cash, check, credit card, or electronic transfer as agreed.

Clause 4 – Cancellation and Rescheduling

Cancellations or rescheduling by the Client must be made at least 48 hours in advance. Failure to do so will result in forfeiture of any deposit amount. The Makeup Artist reserves the right to cancel or reschedule due to emergencies or

uncontrollable circumstances, in which case the Client will receive a full refund of any payments made.

Clause 5 – Client Responsibilities

The Client agrees to disclose any allergies or sensitivities prior to service. The Client must arrive on time and follow any pre-appointment instructions provided by the Makeup Artist. The Makeup Artist is not responsible for adverse reactions if the Client fails to disclose relevant information.

Clause 6 – Liability

The Makeup Artist shall perform services with reasonable skill and care. However, the Makeup Artist is not liable for any allergic reactions or adverse effects arising from products used if such reactions were unforeseeable. The Client agrees to hold harmless and indemnify the Makeup Artist from any claims related to service.

Clause 7 – Use of Images

The Client consents to the Makeup Artist using photographs or videos of the makeup application for promotional or portfolio purposes unless otherwise agreed in writing.

Clause 8 – Confidentiality

Both parties agree to maintain confidentiality regarding personal information and sensitive details disclosed during the course of this Agreement.

Clause 9 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to its conflict of laws principles.

Clause 10 – Entire Agreement

This Agreement constitutes the entire agreement between the parties. Any modifications or amendments must be made in writing and signed by both parties.

Clause 11 – Dispute Resolution

Any disputes arising out of or related to this Agreement shall be resolved first through good faith negotiations. If unresolved, the parties agree to submit to binding arbitration in the State of _____ under the rules of the American Arbitration Association.

Clause 12 – Severability

If any provision of this Agreement is found to be unenforceable or invalid, the remaining provisions shall remain in full force and effect.

Clause 13 – Force Majeure

Neither party shall be liable for any failure or delay in performance due to causes beyond their reasonable control, including but not limited to natural disasters, acts of government, or other unforeseen events.

Clause 14 – Signatures

This Agreement may be executed in counterparts and delivered electronically. Signatures shall be deemed binding and effective as originals.
