Section 1 – Engagement and Services

Client hereby engages Service Provider to perform the services described herein and Service Provider accepts such engagement. Services shall be provided in a professional and workmanlike manner consistent with industry standards.

Section 2 – Term

This Contract shall commence upon execution by both parties and shall continue until services are completed or terminated as provided herein.

Section 3 – Compensation

Client shall pay Service Provider the compensation stated above upon the terms agreed. Unless otherwise specified, payment is due within thirty (30) days of invoice receipt.

Section 4 – Expenses

Client agrees to reimburse Service Provider for reasonable and necessary expenses incurred in connection with the performance of services, provided such expenses are pre-approved in writing by Client.

Section 5 – Independent Contractor

Service Provider shall perform the services as an independent contractor and not as an employee or agent of Client. Nothing herein shall be construed to create a partnership, joint venture, or agency relationship.

Section 6 – Confidentiality

Both parties agree to keep confidential all proprietary or non-public information obtained during the course of this Contract and to use such information only for purposes of performing this Contract.

Section 7 – Intellectual Property

All intellectual property rights arising from the services performed under this Contract shall be assigned to Client upon full payment, except for any pre-existing intellectual property of Service Provider.

Section 8 – Warranties and Representations

Service Provider represents and warrants that it has the expertise and authority to perform the services and that services will be performed in compliance with applicable laws and regulations.

Section 9 – Indemnification

Each party agrees to indemnify and hold harmless the other party from any claims, damages, liabilities, costs, and expenses arising out of its breach of this Contract or negligence.

Section 10 – Limitation of Liability

In no event shall either party be liable for any indirect, incidental, special, consequential, or punitive damages arising out of this Contract.

Section 11 – Termination

Either party may terminate this Contract upon written notice if the other party materially breaches any term of this Contract and fails to cure such breach within fifteen (15) days of notice.

Section 12 – Governing Law and Venue

This Contract shall be governed by the laws of the State of _____ without regard to its conflict of law principles. The parties consent to exclusive jurisdiction and venue in the state or federal courts located in _____ County, _____.

Section 13 – Dispute Resolution

Any disputes arising from this Contract shall first be addressed through good faith negotiations. If unresolved, the parties agree to mediation prior to seeking legal remedies.

Section 14 – Entire Agreement

This Contract constitutes the entire agreement between Client and Service Provider and supersedes all prior negotiations, agreements, or understandings.

Section 15 – Amendments

No modification or amendment of this Contract shall be valid unless in writing and signed by both parties.

Section 16 – Notices

All notices required or permitted hereunder shall be in writing and shall be deemed delivered when delivered personally, by certified mail, or by nationally recognized overnight courier to the addresses listed herein.

Section 17 – Severability

If any provision of this Contract is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Section 18 – Force Majeure

Neither party shall be liable for any failure or delay in performance due to causes beyond its reasonable control, including but not limited to acts of God, war, terrorism, labor disputes, or governmental actions.

Section 19 – Non-Waiver

Failure to enforce any provision of this Contract shall not be deemed a waiver of future enforcement of that or any other provision.

Section 20 – Counterparts

This Contract may be executed in counterparts, each of which shall be deemed an original, but all of which together

constitute one and the same instrument.
