Warranties and Representations:

Designer warrants that the work is original and does not infringe upon the rights of any third party. Client warrants that any materials provided do not violate any laws or rights of third parties. Both parties agree to indemnify and hold harmless the other from any claims arising out of breach of these warranties.

Termination:

Either party may terminate this Agreement upon written notice if the other party materially breaches any term and fails to cure within a reasonable period. Client shall pay Designer for all work performed up to termination date.

Limitation of Liability:

Designer's total liability under this Agreement shall not exceed the total amount paid by Client. In no event shall Designer be liable for any indirect, incidental, special, or consequential damages arising from the services.

Governing Law and Dispute Resolution:

This Agreement shall be governed by the laws of the State of _____ without regard to conflict of law principles. Any dispute arising hereunder shall be resolved by exclusive jurisdiction of courts located in _____ County, _____.

Entire Agreement and Amendments:
