Terms and Conditions:

1. Service Provider Responsibilities

The Service Provider shall provide all staff, equipment, and supplies necessary to perform the mobile bar services described herein in a professional and timely manner.

2. Client Responsibilities

The Client shall provide access to the event location, necessary permits and licenses, and ensure compliance with all local laws and regulations regarding alcohol service.

3. Alcohol Service Compliance

The Service Provider agrees to comply with all applicable federal, state, and local laws, including verifying legal

drinking age and refusing service to intoxicated guests.

4. Cancellation Policy

Either party may cancel this Agreement by providing written notice. Deposits are non-refundable unless cancellation is due to breach by the other party.

5. Indemnification

Client agrees to indemnify and hold harmless the Service Provider from any claims, damages, or liabilities arising from the event except to the extent caused by the Service Provider's gross negligence or willful misconduct.

6. Liability Limitations

The Service Provider's liability is limited to the amount paid under this Agreement. The Service Provider is not liable for any indirect or consequential damages.

7. Force Majeure

Neither party shall be liable for failure to perform due to circumstances beyond their reasonable control, including but not limited to acts of God, government restrictions, or other emergencies.

8. Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____. Any disputes shall be resolved in the state or federal courts located in _____ County, _____.

9. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations and understandings. Amendments must be in writing and signed by both parties.

10. Severability

If any provision is found invalid or unenforceable, the remaining provisions shall remain in full force and effect.

11. Insurance

Service Provider maintains general liability insurance covering the services provided.

12. Event Conduct

The Client agrees to maintain order during the event and ensure guests conduct themselves responsibly.

13. Additional Services

Any services beyond the scope of this Agreement must be mutually agreed upon in writing.

14. Equipment Damage

Client is responsible for cost of repair or replacement of any equipment damaged due to Client or guests' negligence.

15. Assignment

Neither party may assign this Agreement without prior written consent of the other party.

16. Notices

All notices shall be in writing and delivered personally, by certified mail, or by electronic mail with confirmation.

17. Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original.

18. Signatures

The parties have read, understood, and voluntarily accept the terms of this Agreement.
