1. Scope of Services

Mover agrees to provide moving services including packing, loading, transporting, unloading, and unpacking of Customer's goods as described in this Agreement. Mover shall perform services in a professional and workmanlike manner.

2. Access and Conditions

Customer shall provide safe and adequate access to both origin and destination locations for moving equipment and personnel. Mover shall not be responsible for delays or additional costs due to inaccessible or unsafe areas.

3. Packing and Loading

Customer may elect to pack items themselves or request packing services from Mover. Mover shall not be responsible for damage to items improperly packed by Customer.

4. Inventory and Valuation

An inventory of goods to be moved will be prepared by Mover and Customer prior to loading. Customer shall declare the value of goods for insurance and liability purposes. Mover's liability shall be limited as set forth in this Agreement.

5. Payment Terms

Customer agrees to pay the fees specified herein according to the agreed schedule. Failure to timely pay may result in

delay or refusal of service and additional charges.

6. Cancellation and Rescheduling

Customer must provide at least 48 hours' notice for cancellations or rescheduling. Fees may apply for late cancellations or no-shows.

7. Liability and Insurance

Mover shall exercise reasonable care in handling Customer's goods. Mover's liability for loss or damage is limited to the declared value or as provided by applicable law. Customer is encouraged to obtain additional insurance coverage if desired.

8. Claims and Disputes

Customer shall inspect goods upon delivery and report any loss or damage immediately. Claims must be submitted in writing within 30 days of delivery. Parties agree to attempt resolution through mediation before pursuing litigation.

9. Indemnification

Customer agrees to indemnify and hold Mover harmless from any claims, damages, or losses arising from Customer's failure to disclose accurate information or from prohibited items.

10. Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____. Any disputes shall be resolved exclusively in the courts located in _____ County, _____.

11. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior communications. Any amendments must be in writing and signed by both parties.

12. Force Majeure

Mover shall not be liable for delays or failure to perform due to causes beyond its reasonable control, including acts of God, government actions, labor disputes, or transportation interruptions.

13. Severability

If any provision of this Agreement is found invalid or unenforceable, the remainder shall remain in full force and effect.

14. Signatures and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together shall constitute one agreement.
