Agreement Clauses:

Clause 1 – Scope of Work

Artist agrees to create the mural described herein at the Project Location in accordance with the specifications and timeline mutually agreed upon by both parties.

Clause 2 – Materials and Equipment

Artist shall supply all materials, tools, and equipment necessary for the completion of the mural unless otherwise specified in writing.

Clause 3 – Access and Permissions

Client shall provide Artist with reasonable access to the Project Location and any necessary permissions or permits required for the mural installation.

Clause 4 – Payment Terms

Client agrees to pay Artist the Total Fee as specified, according to the Payment Schedule. All payments shall be made

in USD and are due as outlined unless otherwise agreed in writing.

Clause 5 – Changes and Modifications

Any changes to the mural design, specifications, or schedule must be agreed upon in writing by both parties and may be subject to additional fees.

Clause 6 – Intellectual Property Rights

Artist retains all intellectual property rights in the mural design. Client is granted a non-exclusive license to display the mural at the Project Location.

Clause 7 – Use of Images

Artist may use photographs or images of the completed mural for promotional and portfolio purposes unless Client explicitly prohibits such use in writing.

Clause 8 – Warranties and Representations

Artist warrants that the mural will be original work and does not infringe on any third-party rights. Client warrants that the Project Location is suitable for the mural.

Clause 9 – Liability and Indemnification

Each party agrees to indemnify and hold harmless the other from any claims, damages, or liabilities arising from their respective actions or omissions related to this Agreement.

Clause 10 – Termination

Either party may terminate this Agreement upon written notice if the other party materially breaches any term and fails to cure such breach within a reasonable timeframe.

Clause 11 – Force Majeure

Neither party shall be liable for delays or failure to perform caused by events beyond their reasonable control, including but not limited to natural disasters, acts of government, or labor disputes.

Clause 12 – Governing Law and Jurisdiction

This Agreement shall be governed by the laws of the United States and any applicable state law. Any disputes shall be resolved in the courts located within the appropriate jurisdiction.

Clause 13 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, oral or written, relating to the subject matter herein.

Clause 14 – Amendments

Any amendments or modifications to this Agreement must be made in writing and signed by both parties.

Clause 15 – Notices

All notices required under this Agreement shall be in writing and delivered personally, by certified mail, or electronic means with confirmation of receipt.

Clause 16 – Severability

If any provision of this Agreement is found to be unenforceable, the remaining provisions shall remain in full force and effect.

Clause 17 – Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which constitute one and the same instrument.

Clause 18 – Waiver

No waiver of any breach of this Agreement shall be deemed a waiver of any subsequent breach.

Clause 19 – Assignment

Neither party may assign or transfer their rights or obligations under this Agreement without prior written consent of the other party.

Clause 20 – Signatures

This Agreement is executed by the authorized representatives of the parties and is effective upon their signatures below.
