Section 1 – Scope of Services

The Technician agrees to provide professional nail care services to the Client as specified above. Services will be performed in a professional and workmanlike manner in accordance with industry standards and applicable health and safety regulations.

Section 2 – Licenses and Compliance

The Technician represents and warrants that they hold all necessary licenses, permits, and certifications required to perform the services described herein and that all services will comply with applicable local, state, and federal laws.

Section 3 – Client Responsibilities

The Client agrees to provide accurate health information and to notify the Technician of any allergies, skin conditions, or other factors that may affect the services. The Client acknowledges that results may vary and accepts the risks associated with nail treatments.

Section 4 – Payment and Fees

The Client agrees to pay the fees set forth above according to the agreed payment schedule. Deposits, if required, are non-refundable unless otherwise agreed in writing. Late payments may be subject to additional fees or suspension of services.

Section 5 – Cancellation and Rescheduling

Either party may cancel or reschedule appointments with at least 24 hours' notice. Failure to provide such notice may result in forfeiture of deposits or fees as liquidated damages.

Section 6 – Liability and Indemnification

The Technician shall not be liable for any indirect, incidental, or consequential damages arising from the services provided. The Client agrees to indemnify and hold harmless the Technician from any claims, damages, or liabilities resulting from Client's failure to disclose relevant health information or misuse of products.

Section 7 – Health and Safety

The Technician follows all applicable health and safety guidelines to minimize risks. However, the Client acknowledges that allergic reactions, infections, or other adverse effects may occur and agrees to release the Technician from liability for such occurrences.

Section 8 – Confidentiality and Privacy

Both parties agree to keep all personal and business information received during the provision of services confidential and shall not disclose such information to third parties except as required by law.

Section 9 – Term and Termination

This Agreement shall commence upon execution and continue until completion of the services or termination by either party with written notice. Termination shall not relieve the Client of payment obligations for services already rendered.

Section 10 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements or understandings, whether written or oral, relating to the subject matter herein.

Section 11 – Amendments

Any amendments or modifications to this Agreement must be made in writing and signed by both parties to be effective.

Section 12 – Governing Law and Dispute Resolution

This Agreement shall be governed by and construed in accordance with the laws of the United States and the state where the services are performed. Any disputes arising under this Agreement shall be resolved through good faith negotiation or, if necessary, binding arbitration in accordance with the rules of a recognized arbitration organization.

Section 13 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Section 14 – Waiver

Failure by either party to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other rights hereunder.

Section 15 – Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, government actions, strikes, or pandemics.

Section 16 – Independent Contractor

The Technician is an independent contractor and nothing in this Agreement creates an employer-employee relationship, partnership, or joint venture between the parties.

Section 17 – Insurance

The Technician represents that they maintain adequate liability insurance coverage for the services provided and shall provide proof of insurance upon request.

Section 18 – Signatures and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together constitute one agreement. Electronic signatures shall be deemed as valid and binding as original signatures.
