The Payor agrees to pay the Payee the total amount specified above according to the following schedule and terms. All payments shall be made by the agreed method and must be received by the Payee in cleared funds on or before the due dates. Late payments may incur additional fees or interest as specified herein or by applicable law.

Representations and Warranties:

Each party represents and warrants that it has the full legal right and authority to enter into this Payment Agreement Contract and to perform its obligations hereunder. The Payor represents that all payments will be made from legitimate funds and not derived from illegal activities.

Default and Remedies:

If the Payor fails to make any payment when due, and such failure continues for more than a reasonable cure period after written notice, the Payee may declare the entire remaining balance immediately due and payable and pursue any remedies available at law or equity, including but not limited to collection costs and attorney's fees.

Governing Law and Jurisdiction:

This Payment Agreement Contract shall be governed by and construed in accordance with the laws of the United States and the applicable state law where the Payee maintains its principal place of business. The parties consent to the exclusive jurisdiction and venue of the courts located therein for any disputes arising out of or relating to this Contract.

Confidentiality:

The parties agree to keep confidential all terms and information relating to this Payment Agreement Contract, except as required by law or as necessary to enforce any rights or obligations under this Contract.

Entire Agreement and Amendments:

This Contract constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all

prior agreements, negotiations, and understandings. Any amendments or modifications must be in writing and signed by both parties to be effective.

Notices:

All notices, requests, demands, or other communications required or permitted under this Contract shall be in writing and deemed properly given when delivered personally, by certified mail return receipt requested, overnight courier, or electronic transmission with confirmation to the addresses provided above or such other address as a party may designate by notice.

Severability:

If any provision of this Contract is held invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall continue in full force and effect without being impaired or invalidated in any way.

Waiver:

No failure or delay by either party in exercising any right, power, or privilege under this Contract shall operate as a waiver thereof, nor shall any single or partial exercise preclude any other or further exercise of any right.

Counterparts and Electronic Signatures:

This Contract may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument. Electronic signatures shall be deemed as valid and binding as original signatures.
