Services to be Provided:

Stylist agrees to provide personal styling services to Client which may include wardrobe analysis, outfit coordination, shopping assistance, personal appearance consultation, and related styling services as agreed upon by both parties. Services will be provided in person, remotely, or a combination thereof.

Term and Termination:

This Agreement shall commence upon signature by both parties and continue until the completion of the agreed services or until terminated by either party with written notice. Upon termination, Client shall pay for all services rendered and expenses incurred up to the termination date.

Fees and Payment:

Client agrees to pay Stylist the agreed fee for services rendered. Payment shall be made according to the schedule and methods agreed upon in writing. Late payments may be subject to interest or collection fees as permitted by law.

Expenses:

Client shall reimburse Stylist for any pre-approved out-of-pocket expenses incurred in connection with the performance of services, including but not limited to travel, purchases for Client, and other related costs.

Confidentiality:

Stylist agrees to maintain the confidentiality of all Client information and materials obtained during the course of providing services and shall not disclose such information to any third party without Client's prior written consent, except as required by law.

Independent Contractor:

Stylist is an independent contractor and not an employee, agent, or partner of Client. Stylist shall have no authority to bind Client in any manner.

Limitation of Liability:

Stylist shall not be liable for any indirect, incidental, special, consequential, or punitive damages arising out of or relating to this Agreement or the services provided. Client agrees that Stylist's total liability shall not exceed the fees paid by Client under this Agreement.

Indemnification:

Client agrees to indemnify, defend, and hold harmless Stylist from any claims, damages, liabilities, and expenses arising out of Client's breach of this Agreement or Client's negligence or willful misconduct.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the United States and the State in which the services are primarily performed, without regard to conflict of laws principles. Any disputes shall be resolved through binding arbitration or in courts located within said State, as agreed by the parties.

Entire Agreement; Amendments:

This Agreement constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior agreements and understandings. No amendment shall be effective unless in writing and signed by both parties.

Severability:

If any provision of this Agreement is determined to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

Force Majeure:

Neither party shall be liable for delays or failures in performance resulting from causes beyond their reasonable control, including but not limited to acts of God, natural disasters, pandemics, war, terrorism, or government action.
