Clause 1 – Purpose of Agreement

Seller agrees to sell and Buyer agrees to purchase the pet described above on the terms set forth in this Agreement.

Seller represents that Seller has full right and authority to transfer ownership of the pet.

Clause 2 – Pet Condition and Health

The pet is sold AS-IS, WHERE-IS, with all faults, and Seller makes no warranties or guarantees regarding the pet's health or behavior except as expressly stated herein. Buyer acknowledges having had the opportunity to examine the pet and accepts the pet's condition.

Clause 3 – Veterinary Records and Disclosure

Seller shall provide all veterinary records, including vaccination history, medical treatments, and any known health conditions. Seller discloses all known health issues and behavioral characteristics.

Clause 4 – Buyer's Responsibility

Buyer agrees to provide adequate care, food, shelter, and veterinary attention to the pet and accepts all responsibility for

the pet upon transfer of ownership.

Clause 5 – Return Policy

Buyer may return the pet to Seller within ____ days for any health reasons substantiated by a licensed veterinarian, with a full refund of the purchase price. Beyond this period, all sales are final.

Clause 6 – Spay/Neuter Agreement

Buyer agrees to spay or neuter the pet within ____ months of transfer unless otherwise agreed in writing.

Clause 7 – Liability and Indemnification

Buyer assumes all liability for the pet after transfer and agrees to indemnify and hold Seller harmless from any claims, damages, or expenses arising from the pet's actions.

Clause 8 – Transfer of Ownership

Ownership of the pet transfers to Buyer upon execution of this Agreement and payment in full. Seller shall provide all necessary documentation to facilitate transfer.

Clause 9 – Governing Law

This Agreement shall be governed by and construed under the laws of the State of _____ without regard to its conflict of law principles.

Clause 10 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements. Any amendments must be in writing and signed by both parties.

Clause 11 – Severability

If any provision of this Agreement is found unenforceable, the remaining provisions shall remain in full force and effect.

Clause 12 – Notices

All notices under this Agreement must be in writing and delivered by hand, certified mail, or email with confirmation to the addresses provided by the parties.

Clause 13 – Signatures; Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together constitute one agreement.
