## Clause 1 – Agreement to Provide Pet Sitting Services

The Pet Sitter agrees to provide pet sitting services to the Owner for the pet(s) described above, in accordance with the terms of this Agreement. The Pet Sitter shall exercise reasonable care and skill in providing such services.

## Clause 2 – Owner’s Representations and Responsibilities

Owner represents that all information provided about the pet(s) is complete and accurate. Owner shall provide all necessary supplies, medications, and instructions required for proper care of the pet(s). Owner shall notify Pet Sitter of any changes or special conditions.

## Clause 3 – Pet Sitter’s Duties and Limitations

Pet Sitter shall provide the services as described, including feeding, exercising, administering medication, and any other agreed-upon tasks. Pet Sitter shall not be liable for any injury, illness, or death of the pet(s) unless caused by gross

negligence or willful misconduct.

**Clause 4 – Payment**

Owner agrees to pay the fees specified in this Agreement according to the payment terms. Payment is due upon completion of services unless otherwise agreed in writing. Late payments may incur additional charges.

**Clause 5 – Cancellation and Termination**

Either party may terminate this Agreement with written notice to the other. Owner agrees to provide at least 24 hours notice for cancellations. Fees may apply for late cancellations or early termination.

**Clause 6 – Emergency Care and Veterinary Treatment**

In the event of an emergency or illness, Pet Sitter is authorized to seek veterinary care for the pet(s) and Owner agrees to be responsible for all related expenses. Pet Sitter will make reasonable efforts to contact Owner prior to treatment.

**Clause 7 – Indemnification**

Owner agrees to indemnify and hold harmless Pet Sitter from any claims, damages, or liability arising from the pet(s) behavior, including bites, injuries, or property damage.

**Clause 8 – Personal Property**

Owner acknowledges that Pet Sitter is not responsible for loss or damage to Owner's personal property during the provision of services except where caused by Pet Sitter's gross negligence.

**Clause 9 – Governing Law and Venue**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_. Any disputes arising from this Agreement shall be resolved in the courts located within \_\_\_\_\_ County, \_\_\_\_\_.

**Clause 10 – Entire Agreement**

This Agreement represents the entire understanding of the parties and supersedes all prior negotiations or agreements, whether written or oral. Any amendments must be made in writing and signed by both parties.

**Clause 11 – Confidentiality**

Both parties agree to maintain the confidentiality of any personal or proprietary information disclosed during the term of this Agreement.

**Clause 12 – Liability Waiver**

Owner understands and accepts all risks associated with pet sitting services and waives any claims against Pet Sitter except in cases of gross negligence or willful misconduct.

**Clause 13 – Force Majeure**

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including natural disasters, acts of God, or government restrictions.

**Clause 14 – Severability**

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

**Clause 15 – Signatures and Counterparts**

This Agreement may be executed in counterparts, each of which shall be deemed an original. Electronic or scanned signatures shall have the same force and effect as original signatures.
