Client is granted a non-exclusive, non-transferable license to use the photographs for personal or commercial purposes as outlined in this Agreement. Any additional uses require prior written consent of the Photographer.

Deliverables and Timeline:

Photographer agrees to deliver the final edited photographs in digital format within the agreed timeline following the photography session. Delivery method will be agreed upon by both parties. Any delays due to unforeseen circumstances will be communicated promptly.

Cancellation and Refunds:

Either party may cancel this Agreement with written notice. Deposits paid are non-refundable except in cases where the Photographer cancels. If the Client cancels within 72 hours of the scheduled session, the deposit will be forfeited. Rescheduling is subject to availability.

Liability and Indemnification:

Photographer will take reasonable care in performing the services but is not liable for any injury, loss, or damage during the photography session. Client indemnifies and holds the Photographer harmless from any claims, damages, or expenses arising from the Client's actions or failure to disclose relevant information.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising under this Agreement shall be resolved by binding arbitration conducted in _____ County, _____ according to the rules of the American Arbitration Association. Both parties waive the right to a trial by jury.

Entire Agreement; Amendments:

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements and understandings, whether oral or written. Amendments must be made in writing and signed by both parties.

Severability:

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
