1. Scope of Services

Photographer agrees to provide professional photography services as described above, including editing and delivery of final images in digital format unless otherwise agreed.

2. Client Responsibilities

Client shall provide Photographer with reasonable access to locations and subjects, and cooperate to facilitate the completion of services.

3. Payment

Client agrees to pay Photographer the agreed Total Fee. Deposit, if any, is non-refundable and payable upon contract execution. Balance is due on or before the delivery of final images. Late payments may incur interest or collection costs.

4. Cancellation and Rescheduling

Client or Photographer may cancel or reschedule with at least 7 days' notice. Deposit shall be forfeited if Client cancels within less than 7 days. Rescheduling subject to Photographer's availability.

5. Delivery Timeline

Photographer shall deliver final images within a reasonable timeframe following the event or session, typically within

30 days.

6. Intellectual Property Rights

Photographer retains copyright to all images. Client is granted a non-exclusive, non-transferable license for personal use. Commercial use requires separate licensing agreement.

7. Model Release and Usage

Client grants Photographer the right to use images for promotional purposes unless Client provides written notice to restrict usage.

8. Limitation of Liability

Photographer's liability for any claim related to this Agreement shall not exceed the Total Fee paid. Photographer is not liable for indirect, incidental, or consequential damages.

9. Indemnification

Client agrees to indemnify and hold Photographer harmless from claims arising out of Client's misuse or unauthorized distribution of images.

10. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, United States, without regard to its conflict of law provisions.

11. Entire Agreement

This document constitutes the entire agreement between the parties and supersedes any prior understandings or agreements. Amendments must be in writing and signed by both parties.

12. Force Majeure

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including but not limited to acts of God, government restrictions, or other emergencies.

13. Confidentiality

Both parties agree to keep confidential any proprietary or sensitive information exchanged during the course of this Agreement.

14. Severability

If any provision is found unenforceable or invalid, the remainder of the Agreement shall remain in full force and effect.

15. Assignment

Neither party may assign this Agreement or any rights hereunder without prior written consent of the other party.

16. Waiver

Failure to enforce any provision shall not constitute a waiver of future enforcement of that or any other provision.

17. Dispute Resolution

Parties agree to attempt to resolve disputes amicably before pursuing litigation. Venue and jurisdiction shall be exclusively in the courts of _____ County, _____.

18. Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original, including electronic signatures.
