Permits and Compliance:

The Service Provider shall obtain and maintain all necessary permits, licenses, and approvals required under federal, state, and local laws to perform the services. All work shall comply with applicable laws, codes, ordinances, and regulations.

Warranties and Representations:

The Service Provider warrants that all services will be performed in a professional and workmanlike manner, free from

defects in workmanship for a period of one year from completion. Materials shall be warranted as per manufacturer's terms. This warranty does not cover damage caused by misuse, neglect, or acts of God.

Indemnification:

Each party agrees to indemnify and hold harmless the other from and against any claims, damages, liabilities, costs, and expenses, including reasonable attorneys' fees, arising out of or resulting from the performance or breach of this Agreement caused by the indemnifying party's negligence or willful misconduct.

Limitation of Liability:

In no event shall either party be liable to the other for any incidental, consequential, indirect, punitive, or special damages arising out of or related to this Agreement, regardless of the form of action, even if advised of the possibility of such damages.

Termination:

Either party may terminate this Agreement upon written notice if the other party materially breaches any term and fails to cure within a reasonable time. Upon termination, Client shall pay for services rendered and materials supplied through termination date.

Dispute Resolution:

Any disputes arising under this Agreement shall first be subject to good faith negotiation between the parties. If unresolved, disputes shall be submitted to binding arbitration under the rules of the American Arbitration Association in the state where the services are performed.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles. The parties consent to the exclusive jurisdiction and venue of the courts located in _____ County, _____.

Entire Agreement and Amendments:

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, oral or written. No amendment or modification shall be effective unless in writing and signed by both parties.

Severability:

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Force Majeure:

Neither party shall be liable for any failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, government restrictions, natural disasters, or labor disputes.

Confidentiality:

The parties agree to keep confidential all non-public information obtained in connection with this Agreement and not to disclose such information to third parties except as required by law.
