1. Engagement and Recording

Guest agrees to appear as a guest on the Podcast described above, to provide information, opinions, and commentary relevant to the Podcast's content. Recording details such as date, time, and format will be coordinated between Guest and Host.

2. Grant of Rights

Guest grants Host a perpetual, worldwide, royalty-free, sublicensable right to use, reproduce, distribute, publicly display, and create derivative works from Guest's recorded content in connection with the Podcast and related promotional materials in any media now known or hereafter devised.

3. Representations and Warranties

Guest represents and warrants that their contributions are original, do not infringe upon any third-party rights, and contain no defamatory, unlawful, or inappropriate content. Guest has all necessary rights and permissions to grant the rights herein.

4. No Compensation

Guest acknowledges that no monetary or other compensation will be provided for their participation unless otherwise agreed in writing.

5. Confidentiality

Guest agrees to keep confidential any non-public information shared by Host prior to or during recording, including topics, questions, or materials expressly marked as confidential.

6. Release and Indemnity

Guest releases Host and associated parties from any claims arising from Guest's participation, including but not limited to claims of defamation, invasion of privacy, or publicity rights. Guest agrees to indemnify and hold harmless Host against any third-party claims resulting from Guest's content.

7. Editing and Content Control

Host has sole discretion over editing, distribution, and presentation of the recording, including removal or alteration of any portion of Guest's content as deemed appropriate.

8. Governing Law and Dispute Resolution

14. No Partnership or Employment

Nothing in this Agreement creates a partnership, joint venture, or employment relationship between Guest and Host.

15. Recording Equipment and Environment

Guest is responsible for providing the necessary equipment and environment for recording unless otherwise agreed.

16. Cancellation and Rescheduling

Either party may cancel or reschedule the recording with reasonable notice. Neither party shall be liable for cancellations due to force majeure events.

17. Use of Guest's Intellectual Property

Guest retains ownership of their pre-existing intellectual property. Host's rights are limited to the recorded content as specified herein.

18. No Warranty

Host provides the Podcast and related services "as is" without warranty of any kind.

19. Indemnification of Guest

Host agrees to indemnify Guest against third-party claims relating to Host's breach of this Agreement or unlawful use of Guest's content.
