Scope of Services:

The Service Provider agrees to perform pool maintenance and cleaning services including, but not limited to, skimming, vacuuming, brushing, chemical balancing, filter cleaning, and routine equipment inspection. Services shall be performed on a regular basis as agreed between the parties.

Service Schedule and Frequency:

Services will be provided on the following schedule: _____. The Service Provider will notify the Client in advance of any changes or necessary additional visits.

Payment Terms:

The Client agrees to pay the Service Provider the agreed rate of \$_____ per service visit or \$_____ per month, payable upon receipt of invoice. Late payments may be subject to a late fee as permitted by applicable law.

Term and Termination:

This Agreement shall commence upon execution and continue until terminated by either party with a written notice sent at least thirty (30) days prior to termination. Termination shall not relieve the Client of payment obligations for services rendered prior to termination.

Client Responsibilities:

The Client shall provide access to the pool and necessary equipment for the Service Provider to perform services. The Client shall maintain adequate water levels and promptly notify the Service Provider of any issues or damages.

Limitation of Liability:

The Service Provider shall perform services with reasonable care and skill. However, the Service Provider shall not be liable for damages caused by conditions beyond its control, including but not limited to equipment failure, Acts of God, or client negligence.

Indemnification:

Each party agrees to indemnify and hold harmless the other party from and against any claims, damages, liabilities, and expenses arising from the other party's breach of this Agreement or negligent acts.

Dispute Resolution:

Any disputes arising from this Agreement shall first be attempted to be resolved through good faith negotiation. If unresolved, disputes shall be submitted to binding arbitration in accordance with the rules of the American Arbitration Association in the state where the services are performed.

Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles.

Entire Agreement:

This Agreement constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior agreements or understandings.

Amendments:

No amendment or modification of this Agreement shall be valid unless in writing signed by both parties.

Severability:

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Waiver:

The failure of either party to enforce any provision of this Agreement shall not be construed as a waiver of such provision or any other provision.
