Either party may terminate this Agreement upon providing at least seven (7) days written notice to the other party. Any fees incurred for lessons already provided are non-refundable. Cancellation of scheduled lessons requires at least 24 hours' notice or fees may be charged.

Instructor agrees to provide professional music instruction, maintain punctuality, and prepare appropriate lesson materials. Student agrees to attend lessons on time, practice between lessons, and behave respectfully during sessions.

Liability and Indemnification:

Instructor shall not be liable for any injury, loss, or damage incurred by the Student or others during lessons or on the property where lessons occur. Student and/or Parent/Guardian agree to indemnify and hold Instructor harmless from any claims arising from participation in lessons.

Make-up Lessons and Absences:

Make-up lessons for absences caused by the Instructor will be scheduled at a mutually agreeable time. Make-up lessons will not be provided for Student absences unless agreed in advance.

Materials and Equipment:

Student is responsible for providing necessary instruments and materials unless otherwise agreed. Instructor will provide teaching materials as needed.

Confidentiality:

Both parties agree to maintain confidentiality of any personal or proprietary information disclosed during the term of this Agreement.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising under this Agreement shall be resolved through mediation, and if unsuccessful, through binding arbitration in accordance with the rules of the American Arbitration Association.

Entire Agreement and Amendments:

This Agreement contains the entire understanding between the parties and supersedes all prior agreements. No amendments or modifications shall be valid unless made in writing and signed by both parties.

Severability:

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.
