Clause 1 – Purpose of Agreement

Seller agrees to sell and Buyer agrees to purchase the puppy identified above, on the terms set forth herein. Seller represents that Seller is the lawful owner of the puppy and has full right, title, and authority to convey ownership.

Clause 2 – Condition and Health Warranty

Seller warrants that the puppy is healthy at the time of sale, has received age-appropriate vaccinations, and has been examined by a licensed veterinarian. Buyer acknowledges the puppy is sold as a living animal and that Seller makes no guarantees beyond the health warranty stated herein.

Clause 3 – Delivery and Transfer of Ownership

Delivery of the puppy shall occur at the agreed location and time. Ownership and risk of loss pass to Buyer upon physical delivery. Buyer agrees to assume all responsibilities and expenses after delivery.

Clause 4 – Return and Refund Policy

Buyer has the right to return the puppy within ____ days of purchase if the puppy is found to have a serious health condition diagnosed by a licensed veterinarian. Buyer must provide written notice to Seller and documentation. Refunds shall be limited to the purchase price, less any expenses incurred.

Clause 5 – Spay/Neuter Agreement

Buyer agrees to spay or neuter the puppy by the age of ____ months, except if Buyer is a registered breeder or if otherwise agreed in writing by Seller.

Clause 6 – Registration and Pedigree

Seller agrees to provide all necessary documents for registration and pedigree transfer. Buyer agrees to complete and submit registration paperwork promptly.

Clause 7 – Buyer’s Responsibilities

Buyer agrees to provide proper care, nutrition, shelter, and veterinary care for the puppy. Buyer must comply with all applicable laws and regulations, including licensing and vaccination requirements.

Clause 8 – Limitation of Liability

Seller’s liability is limited to the purchase price paid. Seller shall not be liable for any incidental, consequential, or special damages arising from the purchase, ownership, or use of the puppy.

Clause 9 – Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____ without regard to conflict of law principles. The parties consent to exclusive jurisdiction and venue in the state or federal courts located in _____ County, _____.

Clause 10 – Entire Agreement; Amendments

This Agreement, including any attachments or addenda, constitutes the entire agreement between the parties. No amendment or modification is valid unless in writing and signed by both parties.

Clause 11 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Clause 12 – Notice

All notices required or permitted under this Agreement shall be in writing and delivered personally, by certified mail return receipt requested, or by nationally recognized overnight courier, addressed to the parties at their addresses set forth herein.

Clause 13 – Health Records and Documentation

Seller shall provide Buyer with all health records, vaccination certificates, and any other pertinent documentation related to the puppy.

Clause 14 – No Other Warranties

Except as expressly stated herein, Seller makes no other warranties, express or implied, including but not limited to warranties of merchantability or fitness for a particular purpose.

Clause 15 – Return of Deposit

If Buyer fails to complete the purchase for any reason other than breach by Seller, any deposit paid may be retained by Seller as liquidated damages.

Clause 16 – Breach and Remedies

In the event of breach by either party, the non-breaching party shall be entitled to all remedies available at law or equity, including specific performance.

Clause 17 – Counterparts and Electronic Signature

This Agreement may be executed in counterparts and by electronic signature, each of which shall be deemed an original.

Clause 18 – Confidentiality

The terms of this Agreement and any related negotiations shall remain confidential and shall not be disclosed to any third parties except as required by law or agreed upon in writing.

Clause 19 – Buyer’s Acknowledgments

Buyer acknowledges having had the opportunity to inspect the puppy and to ask questions regarding the puppy’s health, behavior, and background.

Clause 20 – Signatures

The parties have read and understood this Agreement and voluntarily accept its terms by their signatures below.
