1. Health Guarantee

Seller guarantees that the puppy is in good health at the time of sale and has received age-appropriate vaccinations and dewormings. This guarantee covers serious contagious diseases that are life-threatening and diagnosed by a licensed veterinarian within the first fourteen (14) days following the buyer's possession.

2. Veterinary Examination

Buyer agrees to have the puppy examined by a licensed veterinarian within 72 hours of taking possession. Failure to obtain such examination voids this guarantee.

3. Genetic Health Guarantee

Seller guarantees the puppy to be free from hereditary and congenital defects that substantially impair health for a period of twelve (12) months from the date of sale. Proof of diagnosis by a licensed veterinarian and written notification to Seller is required.

4. Return and Refund

If the puppy is diagnosed with a serious health condition covered under this guarantee, Buyer may return the puppy to Seller for a full refund or replacement puppy of equal value. The Buyer is responsible for all veterinary and transportation expenses.

5. Exclusions

This guarantee does not cover common minor illnesses, injuries caused by Buyer's negligence, or conditions resulting

from trauma, accidents, or improper care. Puppy must be kept current on vaccinations and veterinary care as recommended.

6. Buyer's Responsibility

Buyer agrees to provide proper nutrition, shelter, exercise, and veterinary care. Failure to do so voids any guarantees herein.

7. Limitation of Liability

Seller's liability is limited to the terms stated in this contract. Seller is not responsible for any incidental, consequential, or special damages.

8. Transferability

This guarantee is non-transferable and applies only to the original Buyer.

9. Governing Law

This contract shall be governed by and construed in accordance with the laws of the State of _____, United States of America.

10. Entire Agreement

This document constitutes the entire agreement between the parties with respect to the subject matter herein and supersedes all prior agreements, understandings, or representations.

11. Amendments

Any modifications or amendments to this contract must be in writing and signed by both parties.

12. Severability

If any provision of this contract is found invalid or unenforceable, the remaining provisions shall continue in full force and effect.

13. Dispute Resolution

Any disputes arising from this contract shall first be attempted to be resolved amicably. If unresolved, disputes shall be subject to binding arbitration in the State of _____ in accordance with the rules of the American Arbitration Association.
