Section 1 – Engagement and Performance

The Promoter hereby engages the Artist to perform live musical entertainment as outlined in this Agreement, and the Artist agrees to perform at the Event on the specified date(s). The Artist shall perform for the duration agreed upon, and the Promoter shall provide a suitable performance environment as reasonably required.

Section 2 – Equipment and Technical Requirements

The Promoter agrees to provide all necessary sound, lighting, and stage equipment to meet the Artist's technical rider, which is attached hereto and incorporated by reference. The Artist will cooperate in advance with the Promoter's technical staff to facilitate setup and soundcheck.

Section 3 – Cancellation

Either party may cancel the performance upon written notice to the other party. If the Promoter cancels less than 30 days prior to the Event, the Promoter shall pay the Artist a cancellation fee equal to 50% of the Total Fee unless the cancellation is due to force majeure or government restrictions. If the Artist cancels, the Artist shall refund any deposits received and make reasonable efforts to recommend a suitable replacement.

Section 4 – Force Majeure

Neither party shall be liable for any failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, war, terrorism, government actions, public health emergencies, or natural disasters.

Section 5 – Independent Contractor

The Artist is engaged as an independent contractor. Nothing herein shall establish an employer-employee relationship, joint venture, or partnership between the parties.

Section 6 – Insurance and Liability

The Promoter shall maintain adequate insurance coverage for the Event, including general liability insurance. The Artist shall not be liable for damages or losses except for those arising from willful misconduct or gross negligence.

Section 7 – Promotion and Advertising

The Promoter shall have the right to use the Artist's name, likeness, and biographical materials for promotional purposes related to the Event, subject to the Artist's prior written approval of materials where reasonably requested.

Section 8 – Merchandising

The Artist retains the exclusive right to sell merchandise at the Event and shall receive 100% of the proceeds from such sales unless otherwise agreed in writing.

Section 9 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles. Any disputes arising hereunder shall be resolved exclusively in the state or federal courts located in _____ County, _____.

Section 10 – Entire Agreement; Amendments

This Agreement constitutes the entire understanding between the parties regarding the subject matter herein and supersedes all prior agreements. Any amendments or modifications must be in writing and signed by both parties.

Section 11 – Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect, and the invalid provision shall be replaced with a valid provision that most closely reflects the intent of the parties.

Section 12 – Signatures and Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together constitute one instrument. Signatures transmitted electronically shall be deemed originals for all purposes.
