Photographer agrees to provide photography services as described herein, including but not limited to the shooting, editing, and delivery of photographs as per the agreed specifications. Services shall be performed at the location(s) and date(s) agreed upon by both parties.

DELIVERY OF PHOTOGRAPHS:

Photographer shall deliver the finished photographs in the agreed format (digital files, prints, albums, etc.) within a reasonable timeframe after the event or session. Delivery method and timelines shall be agreed upon by the parties.

INTELLECTUAL PROPERTY AND USAGE RIGHTS:

Photographer retains all copyrights and intellectual property rights to the photographs. Client is granted a non-exclusive, non-transferable license to use the photographs for personal, non-commercial purposes only, unless otherwise agreed in writing. Any commercial use requires prior written consent of the Photographer.

CANCELLATION AND POSTPONEMENT:

Client may cancel or postpone the photography services by providing written notice to the Photographer. Deposits are non-refundable except as otherwise agreed. If Photographer cancels, all monies paid shall be returned to Client. Rescheduling is subject to Photographer's availability.

LIMITATION OF LIABILITY:

Photographer shall not be liable for any indirect, incidental, special, consequential, or punitive damages arising out of or related to the services provided. In no event shall Photographer's liability exceed the total amount paid by Client under this Agreement.

INDEMNIFICATION:

Client agrees to indemnify and hold harmless Photographer against any claims, damages, or expenses arising from Client's use of the photographs or breach of this Agreement.

GOVERNING LAW AND DISPUTE RESOLUTION:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law provisions. Any disputes arising under this Agreement shall be resolved in the state or federal courts located in _____ County, _____.

ENTIRE AGREEMENT AND AMENDMENTS:

This Agreement constitutes the entire agreement between the parties and supersedes all prior understandings. Any amendments must be in writing and signed by both parties.
