Stud Owner Responsibilities:

Stud Owner agrees to provide healthy, fertile stud dog for mating, to assist as needed during breeding attempts, and to provide current health and vaccination records.

Mating Owner Responsibilities:

Mating Owner agrees to provide healthy, in-heat female (bitch) and to bear all costs related to transportation, veterinary care, and aftercare of the bitch.

Warranties and Representations:

Both parties represent and warrant that all information provided regarding their dogs is true and accurate to the best of

their knowledge. The stud dog is fertile and in good health, and the bitch is in proper condition for mating. No guarantees or warranties are made regarding successful pregnancy or number of puppies. Neither party shall be responsible for any loss or damage arising from failure to produce viable offspring.

Health, Vaccination, and Testing:

Both parties shall provide complete health and vaccination records for their respective dogs prior to mating. Dogs must be free from contagious diseases, parasites, and hereditary conditions that could affect breeding. Both parties agree to provide results from any required genetic or health testing relevant to the breed.

Liability and Indemnification:

Each party agrees to indemnify, defend, and hold harmless the other party from and against any and all claims, damages, liabilities, costs, and expenses arising out of or related to the stud service, including injuries to dogs or persons. Neither party shall be liable for indirect, incidental, or consequential damages. This indemnity survives the termination of this Agreement.

Bitch in Heat and Mating Schedule:

Mating Owner agrees to notify Stud Owner promptly when the bitch comes into heat and to cooperate in scheduling mating attempts. If the bitch is not bred during the current heat cycle, the parties may agree to additional attempts according to terms herein.

Pregnancy and Litter Outcome:

Mating Owner shall notify Stud Owner of pregnancy status and provide updates on litter outcome. If no pregnancy results from the mating, return services may be provided as specified herein. Any disputes regarding litter results shall be resolved according to the dispute resolution clause.

Return Service Terms:

If the bitch fails to conceive as a result of the stud service, one return mating service shall be provided at no additional stud fee, provided that: (a) the Mating Owner notifies the Stud Owner in writing within a reasonable time frame; (b) the bitch was bred in accordance with the terms of this Agreement; and (c) the failure is not due to health or fertility issues of the bitch.

Term, Termination and Cancellation:

This Agreement shall remain in effect until all obligations are fulfilled or until terminated by mutual written consent. Either party may terminate this Agreement upon material breach by the other party, with written notice. Cancellation must be communicated promptly; any fees paid are non-refundable except as expressly stated.

Dispute Resolution and Governing Law:

Any disputes arising under or related to this Agreement shall be resolved first through good faith negotiations between the parties. If unresolved, disputes shall be submitted to binding arbitration in the state of the Stud Dog Owner's

residence, under the rules of the American Arbitration Association. This Agreement shall be governed by and construed in accordance with the laws of the United States and the applicable state law.

Miscellaneous Provisions:

This Agreement constitutes the entire agreement between the parties regarding the stud service and supersedes all prior understandings. No amendments or waivers shall be valid unless in writing and signed by both parties. If any provision is held invalid, the remainder shall remain in full force and effect.
