Section 1 – Engagement

Client hereby engages Photographer to provide styled shoot photography services as described herein, and Photographer agrees to provide such services under the terms of this Agreement.

Section 2 – Scope of Work

Photographer shall conduct a styled shoot including photography of models, locations, props, and related elements as agreed, delivering final edited images as per the mutually agreed deliverables.

Section 3 – Usage Rights and Ownership

Photographer retains all copyrights to the images produced. Client is granted a non-exclusive, non-transferable license for use in promotional and portfolio purposes in accordance with agreed terms. Any commercial use beyond agreed scope requires additional licensing.

Section 4 – Compensation

Client agrees to pay the Total Fee specified above. A Deposit Amount is due upon signing this Agreement to secure Photographer's date and services. The remaining Balance Due shall be paid prior to delivery of final images.

Section 5 – Cancellation and Rescheduling

Client may cancel or reschedule the styled shoot with at least 7 calendar days' notice. Deposit is non-refundable but may be applied to a rescheduled date within 6 months. Cancellations with less than 7 days' notice forfeit the deposit.

Section 6 – Responsibilities

Client shall provide necessary access, permissions, and cooperation for the styled shoot. Photographer will perform services in a professional manner consistent with industry standards.

Section 7 – Deliverables

Photographer will deliver the final edited images within a mutually agreed timeframe. Delivery format, number of images, and any prints or albums shall be as specified separately.

Section 8 – Model Releases

Client shall be responsible for obtaining all necessary model releases and permissions for individuals appearing in the styled shoot unless otherwise agreed in writing.

Section 9 – Limitation of Liability

Photographer shall not be liable for any indirect, incidental, consequential, or punitive damages arising out of the services or use of the images. Total liability shall not exceed the fees paid.

Section 10 – Indemnification

Client agrees to indemnify and hold Photographer harmless from any claims, damages, or expenses arising from Client's breach of this Agreement or misuse of the images.

Section 11 – Confidentiality

Both parties agree to maintain confidentiality of any proprietary or sensitive information exchanged during the course of this Agreement.

Section 12 – Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____. Any disputes shall be resolved exclusively in the state or federal courts located within _____ County, _____.

Section 13 – Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations or understandings. Any modifications must be in writing and signed by both parties.

Section 14 – Severability

If any provision is found to be unenforceable, the remaining provisions shall remain in full force and effect.

Section 15 – Force Majeure

Neither party shall be liable for failure or delay due to causes beyond their reasonable control, including acts of God, war, or government restrictions.

Section 16 – Signatures

This Agreement may be executed in counterparts and by electronic signature, each of which shall be effective and binding.
