Clause 1 – Scope of Services

The Towing Company agrees to provide towing services for the Client's vehicle as described in this Agreement. Services include safe pick-up, transport, and delivery of the vehicle to the designated destination.

Clause 2 – Client Responsibilities

The Client shall provide accurate vehicle information and ensure that the vehicle is free of personal belongings. The Client certifies that they have the authority to authorize towing of the vehicle.

Clause 3 – Fees and Charges

The Client agrees to pay all fees specified herein. Additional charges may apply for extraordinary services, including but not limited to winching, recovery, storage, or after-hours towing.

Clause 4 – Payment Terms

Payment is due upon completion of towing services unless otherwise agreed in writing. Acceptable payment methods

include cash, credit card, or certified check. Non-payment may result in additional fees and collection proceedings.

Clause 5 – Liability and Indemnification

The Towing Company shall exercise reasonable care in the performance of services but is not liable for damage caused by pre-existing conditions, inherent vehicle defects, or Client negligence. The Client agrees to indemnify and hold harmless the Towing Company against any claims arising from the vehicle or its condition.

Clause 6 – Vehicle Condition and Inspection

The Client acknowledges that the vehicle's condition has been inspected prior to tow. Any damages alleged to have occurred during towing must be reported immediately upon delivery and documented in writing.

Clause 7 – Insurance

The Towing Company maintains required insurance coverage as per applicable laws. Coverage limits are available for review upon request. The Client is responsible for their own insurance coverage during transport.

Clause 8 – Storage

If the vehicle is not claimed or paid for within the agreed timeframe, the Towing Company may place the vehicle in storage and charge applicable storage fees. Lien laws will be enforced as required by jurisdiction.

Clause 9 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflict of law principles.

Clause 10 – Dispute Resolution

Any disputes arising under this Agreement shall first be attempted to be resolved through good faith negotiation. If unresolved, disputes may be submitted to binding arbitration in accordance with the rules of the American Arbitration Association.

Clause 11 – Entire Agreement

This Agreement constitutes the entire understanding between the parties with respect to towing services and supersedes all prior agreements, oral or written.

Clause 12 – Amendments

Any amendments to this Agreement must be in writing and signed by both parties.

Clause 13 – Severability

If any provision of this Agreement is found to be unenforceable, the remaining provisions shall remain in full force and effect.

Clause 14 – Notices

All notices shall be in writing and delivered by hand, certified mail, or electronic communication with confirmation to the addresses specified herein.

Clause 15 – Force Majeure

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including acts of God, natural disasters, or government restrictions.

Clause 16 – Safety and Compliance

The Towing Company agrees to comply with all applicable federal, state, and local laws, rules, and regulations governing towing operations.

Clause 17 – Signatures
