Copyright and Usage Rights:

Photographer retains all copyrights to the images produced. Client is granted a limited, non-exclusive license to use the images for personal, non-commercial purposes. Any commercial use, reproduction, or distribution requires prior written

consent from Photographer.

Liability and Indemnification:

Photographer will take reasonable care in performing services but is not liable for any indirect, consequential, or incidental damages arising from the event or the use of images. Client agrees to indemnify and hold harmless Photographer from claims, damages, or expenses arising from Client's breach of this Agreement or misconduct.

Force Majeure:

Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including but not limited to acts of God, natural disasters, government actions, or other unforeseeable events. In such cases, parties will make reasonable efforts to reschedule or negotiate alternatives.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising out of or relating to this Agreement shall be resolved through negotiation in good faith, and if unresolved, through binding arbitration in accordance with the rules of a mutually agreed arbitration service.

Entire Agreement:
